# Background

- CRAC created by CAMA (1974)
- Originally a 45-member local-state advisory body for CRC rule & policy development
- Communications link between the CRC and local governments
- All 20 counties had a designated seat
- 8 coastal cities, 9 state agency, 4 planning, 3 science & technology, 1 local health director



# **Session Law 2013-360**

- Vacated the membership effective July 31, 2013
- Reduced size to 20, all appointed by the CRC
- CRC may accept nominations from local governments
- No designated seats, but minimum 50% coastal residency requirement
- Initial terms expire June 30, 2015



## **Appointments**

- CRC invited nominations from county and local governments, as well as Commission members, from November 2013 through January 2014
- The CRC Executive Committee met by conference call to review the nominees and make initial recommendations
- The CRC Executive Committee is recommending 10 initial appointments; additional nominations welcome
- The Executive Committee recommends revisiting the nominations process at a later date to fill the remaining seats on the CRAC
