PRELIMINARY MATTERS

Dr. White called the meeting to order.

Dr. White read Executive Order No. 1 regarding avoidance of conflict of interest.

Those in attendance introduced themselves. Dr. White announced any potential conflicts with the Commission members and reminded them to recuse themselves from any discussions related to those conflicts.

Dr. White asked for a motion to approve the minutes from the February 7, 2019 meeting. Ms. Deck moved to approve minutes from the February meeting. Mr. Bivens made a second; the motion passed and the minutes were approved. The minutes were signed.

ACTION ITEMS

Rule-Making Process – Mr. Boyd DeVane read through the proposed rules under 15A NCAC Chapter 04 ("Sediment Rules") and presented DEMLR staff's recommendations for revisions and changes. A table listing the Sediment Rules, DEMLR staff's recommendations and proposed changes, and any amendments and changes made to the proposed rules by the Commission, is attached to these minutes.

Mr. Bivens moved to authorize staff to publish the Notice of Text and the Regulatory Impact Analysis for rule set 15A NCAC 04A as proposed. Ms. Deck made a second. The motion passed.

Mr. Bivens moved to authorize staff to publish the Notice of Text and the Regulatory Impact Analysis for rule set 15A NCAC 04B as changed and amended today with changes to rules 15A NCAC 04B .0107 and 15A NCAC 04B .0112, contingent that rules .0107 and .0112 as changed and amended today are reflected in the Regulatory Impact Analysis and approved by OSBM. Ms. Ogallo made a second. The motion passed.

Mr. Bivens moved to authorize staff to publish the Notice of Text and the Regulatory Impact Analysis for rule set 15A NCAC 04C as proposed. Dr. Havlin made a second. The motion passed.

Mr. Bivens moved to authorize staff to publish the Notice of Text and the Regulatory Impact Analysis for rule set 15A NCAC 04D as proposed. Ms. Deck made a second. The

motion passed.

Mr. Bivens moved to authorize staff to publish the Notice of Text and the Regulatory Impact Analysis for rule set 15A NCAC 04E as changed and amended today with changes to rule 15A NCAC 04E .0503, contingent that rule .0503 as changed and amended today is reflected in the Regulatory Impact Analysis and approved by OSBM. Dr. Havlin made a second. The motion passed.

Ms. Deck moved to authorize staff to compose a preamble to the proposed rules highlighting other things the Commission is requesting the public to consider. Ms. Ogallo made a second. The motion passed.

Mr. Bivens moved to authorize the appointment of Mr. Danny Smith, Interim Director of the Division of Energy, Mineral, and Land Resources (DEMLR), to serve as hearing officer for any public hearing to be held at a date determined by the publication of rules in conformance with the schedule for rulemaking as required by the Rules Review Commission. Dr. Havlin made a second. The motion passed.

Local Program Reviews, Recommendations and Votes on Delegation – Mr. Taylor Young summarized the DEMLR staff's review of programs from the Town of Lake Lure, the City of Charlotte, Lincoln County, Jackson County, and New Hanover County. Below are the results of these reviews.

The motions were as follows:

Town of Lake Lure: Ms. Deck moved to continue delegation with review until the August 2019 meeting. Mr. Bivens made a second. The Commission voted to continue delegation of authority for the program upon continued review. The motion passed.

City of Charlotte: Ms. Knotts moved to continue delegation. Ms. Ogallo made a second. The Commission voted to continue delegation of authority for the program. The motion passed.

Lincoln County: Ms. Deck moved to continue delegation. Dr. Rubin made a second. The Commission voted to continue delegation of authority for the program. The motion passed.

Jackson County: Mr. Bivens moved to continue delegation. Ms. Ogallo made a second. The Commission voted to continue delegation of authority for the program. The motion passed.

New Hanover County: Mr. Taylor moved to continue delegation with review until the August 2019 meeting. Ms. Deck made a second. Ms. Deck then moved to amend the motion to have DEMLR staff send a letter to county staff requesting that program staff address a memorandum sent to the regulated community from the County Engineer

regarding changes to the program. Ms. Berry requested that one of the projects reviewed by the DEMLR staff be questioned within this letter. Mr. Bivens made a second to the amendment. The amendment passed. The Commission then voted on the original motion as amended, to continue delegation of authority for the program, with continued review for the next three months until the August 2019 meeting, with DEMLR staff to send a letter to county staff. The motion passed. Ms. Ogallo requested a copy of the memorandum sent from the County Engineer be provided to the Commissioners at the next meeting.

INFORMATION ITEMS

Durham City/County Program Ordinance Review – Mr. Ryan Eaves presented proposed changes regarding their Unified Development Ordinance to the Commission members for comments.

At this point in the meeting, the Chairman informed the members that rule 15A NCAC 04B .0132 was not specifically discussed by staff during the proposed rules presentation. The Chairman asked if any members had any questions or concerns with rule 04B .0132 as proposed with only minor changes, which was voted to be published with rule set 04B. No discussion was needed as no members had any questions or concerns with the rule as proposed and voted to be published with rule set 04B. The action taken on rule set 04B stands.

NC DOT Report – Messrs. Ben DeWit and Jeremy Goodwin from the Roadside Environmental Unit presented an update on the Department's erosion and sedimentation control program. Handouts were provided. During fiscal year 2018, the Department reviewed 948 erosion control plans, conducted 5,307 compliance inspections, issued 7 Immediate Corrective Actions (ICAs), with no NOVs issued by the DEMLR. The Department maintains its relationship with NC State University in providing certification training and requirements from its consultants and contractors. Ms. Deck asked about the status of the program's review. Mr. DeWit stated that there have been four site reviews conducted so far, with additional reviews scheduled in June of 2019.

NC DOT Report – Ms. Julie Coco presented one Immediate Corrective Action report and one Trout Buffer Waiver as being issued within the quarterly reporting period.

Overview of the Remission Process – Ms. Coco reminded the members of the previously approved procedures for how the DEMLR handles penalty remission requests.

Update to the Program Evaluation Division Study – Mr. Vinson provided an update on Senate Bill 70. There has been no movement on this bill. Because there are monies involved, it is not subject to crossover deadlines. The possibility exists that it will be carried over into the next long session of the legislature. The DEMLR is moving forward with programmatic changes in anticipation of the passing of this bill. One of the provisions of

the bill will require a report to the Sedimentation Control Commission by January 1, 2020.

The Chairman postponed the presentations and discussions of all remaining information items until the next quarterly meeting in August.

CONCLUSION

Remarks by Chief of Program Operations – Mr. Vinson discussed the two vacancies within the Division. He introduced Mr. Gantt as the new Chief of Regional Operations. Mr. Vinson thanked the Commissioners for their support.

Adjournment – Dr. White suggested to adjourn the meeting. Ms. Knotts made a motion to adjourn the meeting. Mr. Bivens made a second. The motion passed. The meeting was adjourned at approximately 2:57 PM.
