240211 – Collections Systems Wastewater Operator Need-to-Know

Current Collections Systems NTK is from 2004 and needs updating. Commissioner Stines has worked with subject matter experts, and we now have a 2019 version. We need to do a final review and approval in 2024. We will use the Subsurface NTK review logistics as a guide.

We need two Commissioners to join Commissioner Stines on a Collections NTK committee. Staff will work with them and subject matter experts to produce a final draft for Commission approval.

Commissioners Rubin and Barry volunteered to be on the Collections Needs-to-Know committee with Commissioner Stines. Staff will contact the Commissioners to begin the process.

240208 – Remote Continuing Education Availability

Currently continuing education is approved through December 31, 2024. Providers need time to plan their curriculum so we need a decision preferably by the May 2024 Commission meeting. Does the WPCSOCC wish to allow the temporary approval to continue to offer virtual training beyond the December 2024 expiration date?

Discussion:

- What is the intent of continuing education? Is it to educate operators and increase their knowledge?
- The only way to know if it increases knowledge would be to have exams on continuing education. We don't think that is something we want to do.
- Discussion about how in person training is better but students can still just sit in a classroom and not be actively involved.
- Do we feel strongly enough about requiring in person continuing education?
- There are advantages of virtual education, especially in remote or rural areas.
- Being in a room with other operators is useful for idea sharing, even outside of the class topic.
- Is there a way to require some in person credits? That would be difficult.
- Can we research what other commissions are doing?

Background:

At the November 3 2023 meeting, it was decided to hold the one candidate received in 2024 until February 9, 2024 to consider adjusting the deadline and announcement for future awards.

Update the application to include all types of waste and animal operators if possible and to include a reference to the DEQ Regional office.

Set the annual nomination deadline for June 1.

Commission decides in August if an operator will be given the award.

Work with NC One Water and NC Rural Water Association to present the award live at their respective conferences (November and May.)

Motion to move the application deadline to June 1, include the current applicant in the June 1, 2024 deadline submission, and require communication with the DEQ Regional Offices. (Barry)

Staff also included a report of biological wastewater 1-4 classes by school provider by grade for the December 2023 exams. Staff is working to improve the reporting of: Passing Rates of All Schools by Providers Over Time.

Discussion:

- The December 2023 and the Historical pass rates for Biological Wastewater are not good.
- These exams are our gatekeepers to operator certification so we don't want 100% pass rates.

2402B - Eastern Band of Cherokee Indians (EBCI) Facility committee update

Background: The Cherokee Wastewater Treatment Plant, run by the Eastern Band of Cherokee Indians (EBCI) contacted the Operator Certification Program about operators trying to apply for the Collections 2 exam. Requirements for the CS-2 exam include 6 months of experience at a CS-1 classified facility. This facility is not classified by NC. It is a federally classified facility and NC does not have jurisdiction over it. The collection system falls under the NPDES permit for the wastewater treatment plant (WW-4). NC classifies treatment plants and collection systems separately. Staff is unable, by rule, to approve these exam applications. This affects several operators. A committee of Commission Council Christine Ryan, Commissioner Groom, Commissioner Rubin and Jeff Talbott has will look into these issues.

Update:

The Committee is researching other states and contacting the EPA to learn how others work through this complication.

It is possible the EBCI operators can apply for NC reciprocity certification through inclusion on the Water Professional International (WPI) ABC registry.

The Committee will meet and report back at the next Commission meeting.
