

# Carolina Poultry Power RG3 – Public Comment Period

## PROPOSED PROJECT

Carolina Poultry Power RG3, LLC, a proposed biomass-to-energy facility, applied to the N.C. Division of Air Quality (DAQ) for a permit to operate a lime storage silo and a boiler to burn used poultry bedding to make electricity.

The facility would be classified as synthetic minor. The draft permit contains conditions limiting the facility’s emissions to below major source (Title V) thresholds:

- Criteria pollutants are each limited to 100 tons per year.
- Individual hazardous air pollutant (HAP) emissions are limited to 10 tons per year.
- Total HAP emissions are limited to 25 tons per year.

The facility must properly operate and maintain emissions control equipment. Atmospheric dispersion modeling reviewed by DAQ shows the facility can comply with health-based standards.

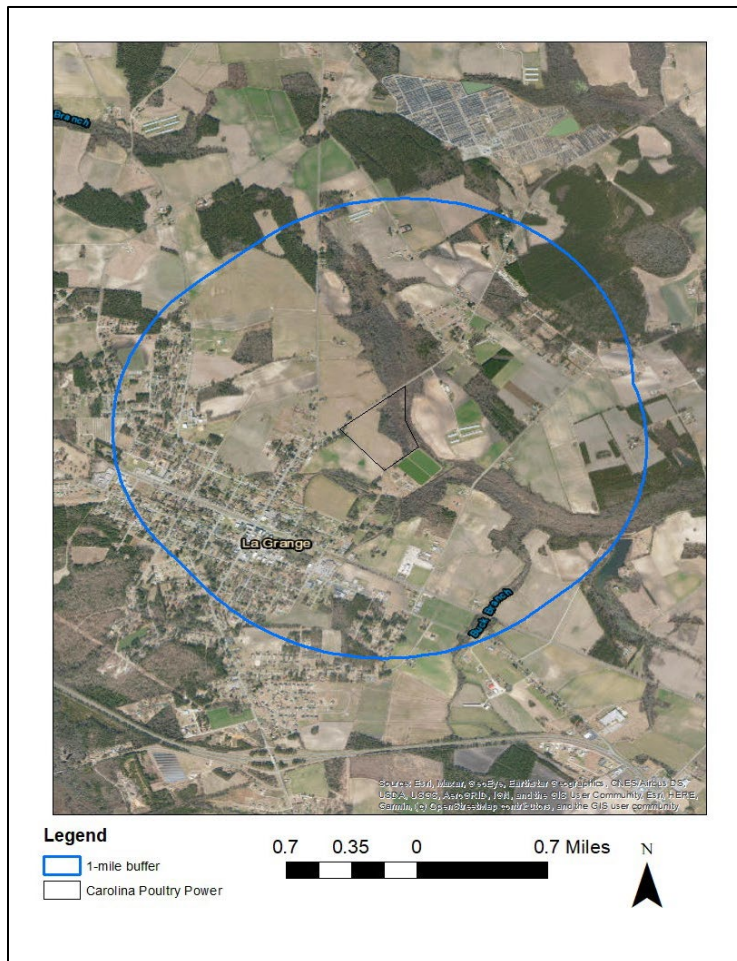
## Project Location

As proposed, Carolina Poultry Power RG3 would be on Brothers Road, La Grange, NC 28551 (Lenoir County Tax Parcel No. 15787). The address is near the intersection of NC Highway 903 N and Brothers Road.

## Potential Emissions

The below table gives an overview of the facility’s potential emissions after installing pollution controls.
