

**NOTICE FOR THE RESCHEDULING OF A PUBLIC HEARING AND
EXTENSION OF COMMENT PERIOD
PRELIMINARY DETERMINATION REGARDING
APPROVAL OF AN APPLICATION SUBMITTED UNDER THE
“REGULATIONS FOR THE PREVENTION OF SIGNIFICANT
DETERIORATION OF AIR QUALITY”

NORTH CAROLINA RENEWABLE POWER – LUMBERTON, LLC**

North Carolina Renewable Power - Lumberton, LLC has applied to the North Carolina Department of Environmental Quality, Division of Air Quality (DAQ) for the implementation of Best Available Control Technology on two, non-CISWI subject wood/ poultry litter-fired boilers at the facility located at:

1866 Hestertown Road
Lumberton, NC 28358
Robeson County.

The proposed project is subject to review and processing under North Carolina Administrative Code (NCAC), Title 15A, Subchapter 02D.0530, “Prevention of Significant Deterioration” (PSD). The proposed project is a “major modification” under PSD because of significant emission increases of carbon monoxide, nitrogen oxide, sulfur dioxide, volatile organic compounds, particulate matter, sulfuric acid mist, and greenhouse gases.

North Carolina Renewable Power - Lumberton, LLC’s application has been reviewed by the DAQ, Permitting Section in Raleigh, North Carolina to determine compliance with the requirements of the North Carolina Environmental Management Commission air pollution regulations. The results of that review led to the preliminary determination that the proposed project could be approved and the DAQ permit could be issued, if certain permit conditions are met.

This amended notice serves as an extension of the public comment period and Notice of Public Hearing for this proposal. DAQ is providing notice of a rescheduled public hearing by teleconference on **February 21, 2022** to allow for public participation while protecting public health under current guidance to prevent the spread of COVID-19.
