The Town of Alliance's annual contract amount is the monthly amount charged by Waste Industries for July 2017 through June 2018.

Solid Waste pick-up fees are also charged to businesses who wish to participate in solid waste services. One cart is \$13.00 per month and businesses may decide to have up to 3 carts at an additional fee. Residents may also request up to 2 carts at an additional fee. An option is also given to residents to pay for solid waste services for one year at a reduced rate of \$85.00.

The Town of Alliance, at this reporting, has 15 businesses participating in solid waste pick-up and approximately 185 residential.

The County of Pamlico has large bulk containers for the collection of recyclable material, which containers are easily accessibly to residents.
