2. Request for a Major Variance from the Neuse River Riparian Area Protection Rule by Mr. Taylor and Mrs. Caroline Pope for additions at an Existing Single-Family Residence at Vann

Street Raleigh, NC - (Action Item) (Paul Wojoski, Division of Water Resources 401 and Buffer Permitting Branch)

A request has been received for the WQC to grant a Major Variance from the Neuse Riparian Area Protection Rules to Mr. Taylor and Mrs. Caroline Pope for the construction of a home addition consisting of a bedroom and bathroom within Zone 1 and Zone 2 of the buffer at an existing single-family residence at 5249 Vann Street, Raleigh, NC. The proposed project would permanently impact 203 square feet of Zone 1 and 380 square feet of Zone 2 of the buffer at 5249 Vann Street, Raleigh. To mitigate the buffer impact, the applicant proposes to purchase riparian buffer credits from the Division of Mitigation Services. The applicant also proposes to install a raingarden Stormwater Control Measure to provide treatment for the stormwater runoff. Based on the information submitted, DWR staff support this request for a Major Variance from the Neuse Riparian Area Protection Rule because all the requirements in 15A NCAC 02B .0233 have been met. 3. Request for a Major Variance from the Neuse River Riparian Area Protection Rule by Mr. Chris Thickitt for a deck expansion at an existing Single-Family Residence at 10837 Bexhill Drive Cary, NC - (Action Item) (Paul Wojoski, Division of Water Resources 401 and Buffer Permitting Branch)

A request has been received for the WQC to grant a Major Variance from the Neuse Riparian Area Protection Rules to Mr. Chris Thickitt for the expansion of a deck in Zone 1 and Zone 2 of the buffer at an existing single-family residence at 10837 Bexhill Drive, Cary, NC. The proposed project would permanently impact 342 square feet of Zone 1 and 380 square feet of Zone 2 of the buffer at 10837 Bexhill Drive, Cary. To mitigate the buffer impact, the applicant proposes to undertake permitee-responsible mitigation by planting native hardwood species in Zone 1 and Zone 2 of the buffer on his property. Based on the information submitted, DWR staff does not support this request for a Major Variance from the Neuse Riparian Area Protection Rule because all the requirements in 15A NCAC 02B .0233 have not been met.
