

**NOTICE FOR PUBLIC MEETING AND HEARING
PRELIMINARY DETERMINATION REGARDING APPROVAL OF
AN AIR PERMIT APPLICATION FOR
Chemours Company - Fayetteville Works**

Chemours Company - Fayetteville Works has applied to the North Carolina Department of Environmental Quality, Division of Air Quality for approval to construct and operate a thermal oxidizer/scrubber system and a lime processing system at:

Chemours Company - Fayetteville Works' application was reviewed by the Division of Air Quality, Raleigh Central Office to determine compliance with the requirements of the North Carolina Environmental Management Commission air pollution regulations. The results of that review led to the preliminary determination that the project could be approved and the Division of Air Quality permit could be issued, if certain permit conditions are met.

This notice serves as a Notice of Public Meeting and Hearing and Opportunity for Public Comment for this proposal. The Public meeting and hearing will be held at the Bladen Community College Auditorium on February 18, 2019 at 6:30 p.m., located at 7418 Highway 41 West, Dublin, NC 28332. The NCDAQ will hold a public information meeting at 6:30 p.m. with the formal public hearing beginning at 7:00 p.m. In the event of an inclement weather cancellation, rescheduling information will be posted at DEQ.NC.GOV/ChemoursAirPermit.
