Scope and Topics:

 - Risk based approach
 - Enforcement, regulation, penalties, stop work orders
 - DEMLR and DWR cooperation, merger, cross training, how to prevent duplicative efforts
 - Current legislative roadblocks
- Local programs-
 - how to add programs
 - how to make programs more effective
 - funding for local programs
 - enforcement for local programs
- Science and Technical / Incentives
 - Storm events are bigger. How do we deal with that? Design storms.
 - o Drones, pollinator seed mix, mountain BMPS vs rest of state
