Minutes:

The meeting began at 1:30 pm.

Draft meeting minutes from 7/21/22 were approved by consensus.

Mark Taylor began by first going over the review call between himself, Ms. Pageau, DEMLR staff and SCC Chair Dr. White. One outcome was an agreement by Dr. White to begin the process of expanding the Committee from 8 to 12 members. Mr. Taylor asked that, if the Committee has any suggested nominations for new CTC members, to send those by August 31 to Dr. White, Mr. Taylor, and/or Ms. Pageau with Ms. Coco and Ms. Coppa copied. The committee then moved on to workgroup updates beginning with Ms. Pageau updating on her and Mr. Lang's updates on Temporary Construction Entrances. They believe it's ready to go to DEMLR for review and are also leaving the question of if the title should be changed from 'Construction Entrance' to something more generic for DEMLR staff to decide on. One suggestion was 'construction access pad'. Ms. Coppa commented that the [IECA's Glossary of E&SC Standard Terminology](#) uses "Construction Exit Pad".

Mr. Taylor then presented on the practice standard, 6.10 Temporary Seeding. A discussion ensued and edits were made throughout the text. Dr. McLaughlin agreed to research fertilizer

composition ratios for Mr. Taylor and Mr. Taylor is going to look at adding a definition/description of hydroseeding as suggested. Mr. Taylor then moved on to the practice standard, 6.14 Mulching. A discussion ensued and edits were made throughout the text. Mr. Taylor will complete the edits based on the discussion today and submit them to DEMLR for review.

Mr. Pearson volunteered to review his workgroup's standards at the next meeting. Ms. Pageau is okay deferring her workgroup's review of the temporary stream crossing standard.

The next regularly scheduled meeting will be a hybrid meeting and is scheduled for 3:30pm – 5:00pm on September 15, 2022.

Mr. Taylor adjourned the meeting at 3:20 pm.
