

Instructions For Form ERC-4 Contact Information Update Notification Emission Reduction Credits North Carolina Division Of Air Quality

This form is used by holders of emission reduction credit certificates to update contact information for one or more

ERC certificates. If the contact information for more than three certificates is being updated, please attach additional pages containing the information requested in Section III. This form cannot be used to transfer emission reduction credits from one holder to another; if credits are being transferred, please use form ERC-3.

I. Facility Information

This section provides updated information on the holding facility's name and/or mailing address. Please complete this section for all notification forms and use the check boxes at the top of this section to indicate if the facility name and/or official mailing address have changed.

A. Current /Former Site

Name:

Provide the name of the facility holding the ERC certificate. In the event that the facility site name is changing, please provide the current or former facility

site name in this field and provide the new facility site name in Item B.

B. New Facility Name: If the name of the facility holding the emission reduction certificate has

changed, please check the appropriate box at the top of this section and provide

the new facility name in this field.

C. Site Address: The 911 street address (physical location) of the plant or facility, not the

corporate mailing address. Where the Division Of Air Quality (DAQ) would go

to inspect the facility.

D. City: The city in which the plant or facility is located.

E. State: North Carolina already entered.

F. Zip Code: The postal zip code for the plant or facility.

G. County: The county in which the plant or facility is located.

H. Facility ID No. The unique identification number assigned to the facility by the DAQ. This

number is located on the first page of the air permit.

II. Contact for Sale of Certificate

Complete this section if the contact person or his/her address or telephone numbers are changing. It is only necessary to provide the contact information that is changing; for example, if only the mailing address of the contact is new then only items E through H need to be completed.

A. Contact Name: In the event that the name of the contact is changing, please provide the name of

the new contact in this field.

B. Title: If the title of the contact is changing, please provide the new title in this field.

C. Telephone: If the telephone number of the contact is changing, please provide the new

telephone number in this field.

D. Fax: If the fax number of the contact is changing, please provide the new fax number

in this field.

E. Mailing Address: If the mailing address of the contact is changing, please provide the new street

address or P.O. Box in this field.

F. City: If the mailing address of the contact is changing, please provide the new city in

this field.

G. State: If the mailing address of the contact is changing, please provide the new state in

this field.

H. Zip Code: If the mailing address of the contact is changing, please provide the new zip code

in this field.

III. Emission Reduction Credits Affected By These Changes
