## Lincoln and Chatham Counties Win Awards for Excellence in Erosion and Sediment Control

he annual Local Programs Workshop and Awards Banquet was held at the Renaissance Centre in Wake Forest, NC on April 23-24, 2019. The keynote speaker was Dr. Walter Robinson, professor of atmospheric sciences in the Department of Marine, Earth, and Atmospheric Sciences at NC State, and the Interim Director of the NC State Climate Office. This annual workshop brought together delegates from a majority of the 54 local programs throughout the state and specialized in training and discussions of erosion and sediment control issues in North Carolina. Support for the Workshop and Awards Program is provided by the North Carolina Sedimentation Control Commission, NC Department of Environmental Quality, Division of Energy, Mineral, and Land Resources, Land Quality Section, and the Water Resources Research Institute of the University of North Carolina System.

Local erosion and sediment control programs have the ability to exercise greater control over erosion and sediment control in their respective jurisdictions and may often inspect sites more frequently than the state erosion and sediment control program. Furthermore, local erosion and sediment control program ordinances may be more restrictive than state law, giving additional control over erosion and sedimentation control during the development occurring within their respective jurisdictions. The North Carolina Sedimentation Control Commission recognizes the importance and the value of local erosion and sediment control programs in controlling pollution by sedimentation to the waters of North Carolina. In addition to training, the workshop seeks to recognize outstanding local programs. Each year awards of excellence are presented to programs in two categories:

- Small program program providing 0-3 man-years or full-time equivalents supporting erosion and sediment control
- Large program program providing 3+ man-years or full-time equivalents supporting erosion and sediment control

The programs that were nominated for the awards include:

Small Program Nominees:

- Chatham County
- Macon County

Large Program Nominees:

- City of Asheville
- Lincoln County
- Wake County
- Winston-Salem/Forsyth County

This program oversees enforcement of erosion control for the County and holds an inter-local agreement with the Town of Pittsboro that covers Chatham Park, the largest planned development in the state. Chatham County erosion control staff were noted for their adaptation to rapid growth, their frequent inspections, and their enforcement initiatives. This small program contributes four staff members to erosion and sedimentation control. Current staff members within the Watershed Protection Department: Rachael Thorn, Watershed Protection Director; Morgan DeWit, Sr., Watershed Specialist; Drew Blake, Watershed Specialist; and Justin Hasenfus, Watershed Specialist.

Lincoln County received the Local Program Award for Excellence for a large program. The Lincoln Natural Resources Division oversees the enforcement of erosion control for Lincoln County and the City of Lincolnton. Within recent years, the program started using software with mobile capabilities, such that when a penalty is issued for a site, all departments are notified, and building inspections are put on hold until repairs are made and the penalty is paid. Another initiative was created in 2018 to recognize the contractors/ developers/builders that exceed requirements of their erosion control plan.

The County was recognized for their education and outreach initiatives, their progressive use of technology, their clearly defined enforcement policies, and the organization of their program. Staff members for this large program contributed four fulltime equivalents to erosion and sedimentation control. Current staff members include: Danielle Rudisill, Erosion & Sedimentation Control Administrator; Patty Dellinger, Director; Mike Dellinger, Natural Resource Conservationist; and Jamie Martin, Natural Resources Technician.

# NC Sedimentation Control Commission: February Actions

At its meeting on February 7, 2019, the NC Sedimentation Control Commission (SCC) took the following actions:

#### **Delegated Local Programs**

- Village of Whispering Pines: Released from review and approved to continue delegation.
- City of Newton: Voted to extend the program's probationary period for the next six months, with a report to be given at the August meeting.
- Johnston County: Released from review and approved to continue delegation.

### NC General Assembly, Program Evaluation Division's (PED) Study on the Sedimentation Pollution Control Program

DEMLR staff presented the Commission with the results to the PED study, the draft legislation resulting from the report recommendations, and DEMLR's responses. The Commission voted to send a letter of response to the NC General Assembly in support of fee increase with appropriations maintained, as that was a previously discussed topic/concern of the Commission. The Commission decided to discuss at a later time their support for other issues of the Bill Draft.

# NC Sedimentation Control Commission: May Actions

At its meeting on May 29, 2019, the NC Sedimentation Control Commission (SCC) took the following actions:

#### **Rule Making Process**

DEMLR staff reviewed the proposed rules under 15A NCAC Chapter 04 ("Sediment Rules") for the Commission members to vote on the proposed changes and taking them to public notice.

The votes on the rules and rule sets with proposed changes were:

- Subchapter 4A: The Commission voted to authorize DEMLR staff to publish the Notice of Text and Regulatory Impact Analysis as proposed.
- 04B .0107: The Commission voted to amend paragraph (d) to substitute the word "approved" for "issued".
- 04B .0112: The Commission voted against the repeal and in favor of taking rule to public notice as it exists.

### The North Carolina Sedimentation Control Commission

The Sedimentation Control Commission (SCC) was created to administer the Sedimentation Control Program pursuant to the NC Sedimentation Pollution Control Act of 1973 (SPCA). It is charged with adopting rules, setting standards, and providing guidance for implementation of the Act. The composition of the Commission is set by statute to encompass a broad range of perspectives and expertise in areas related to construction, industry, government, and natural resource conservation and quality. All members are appointed by the Governor and serve threeyear terms, except for the Director of the Water Resources Research Institute of the University of North Carolina, who serves as long as they remain Director. The chairman of the SCC is named by the Governor. The following is a list of current members with the organizations they represent:

- Subchapter 4B: The Commission voted to authorize DEMLR staff to publish the Notice of Text and Regulatory Impact Analysis as changed and amended.
- Subchapter 4C: The Commission voted to authorize DEMLR staff to publish the Notice of Text and Regulatory Impact Analysis as proposed.
- Subchapter 4D: The Commission voted to authorize DEMLR staff to publish the Notice of Text and Regulatory Impact Analysis as proposed.
- 04E .0503: The Commission voted that the rule be modified to the proposed text titled "disposition of Request" and containing paragraphs (a) through (h), as found on lines 51 - 56, located on page 21, and continuing on lines 1 - 39 on page 22 of the 'Recommendations for Changes' document provided to the Commission.
- Subchapter 4E: The Commission voted to authorize DEMLR staff to publish the Notice of Text and Regulatory Impact Analysis as changed and amended.

The Commission voted to authorize DEMLR staff to compose a preamble to the proposed rules highlighting the text that the Commission would recommend to the public for considerations. The Commission also voted to authorize the appointment of Danny Smith, DEMLR Director, to serve as hearing officer for any public hearing as required by the Rules Review Commission.

### **Delegated Local Programs**

- Town of Lake Lure: Voted to continue delegation of authority upon continued review.
- City of Charlotte: Voted to continue delegation authority.
- Lincoln County: Voted to continue delegation of authority.
- Jackson County: Voted to continue delegation of authority.
- New Hanover County: Voted to continue delegation with review until the August meeting with the amendment that DEMLR staff also send a letter to county staff to request additional information about recent changes to the program.

# The NCG01 and e-NOI

The NC Construction General Permit NO. NCG010000 or NCG01 was renewed on April 1, 2019. The updated permit does not significantly change the measures that are required to be implemented on construction sites; however, there are some organizational and technical updates. Most notably, there is a new process in which construction sites will obtain official coverage under the NCG01. Permittees who have an E&SC Plan approved on or after April 1, 2019 are required to submit an electronic Notice of Intent (e-NOI) form to receive a Certificate of Coverage (COC). After the completion of the project the permittee will also have to submit an electronic Notice of Termination (e-NOT) form to end coverage.
