Editor notes (SS) #44 - Based on Brunswick County Annual Tonnage Spreadsheet and the seven participating municipality reports, subtracted commingled tonnage that was collected from Ocean Isle Beach, Oak Island, Caswell Beach, Shallotte, Leland, Southport, St James. Commingled tons (6,477 tons in total) are included on municipality reports. Also subtracted commingled dropoff tons (137.17) that are included on Oak Island and Carolina Shores reports. And dropoff OCC tons (173.34) that are included on Bald Head Island and Carolina Shores reports.

Holden Beach and Sunset Beach are included in the county recycling tonnage, not reported separately by the municipalities. Confirmed with Micki Bozeman "They are included in the county's tonnages due to them being subscription like the rest of the unincorporated areas. Meaning the town doesn't pay for their residents to recycle. "

GFL Environmental offers all residents in the unincorporated areas of Brunswick County curbside recycling through a subscription program. The program provides one blue/green, 96 gallon, roll out cart and collections are made every other week. The option to sign up for this program started in July 2012. Seven municipalities in the county participate with GFL Environmental in offering their residents curbside recycling, paid through their property tax.

The biggest change to our commingled recycling program is the increase in price per ton. It went from \$0/ton in FY2010 +
