Project Description: The proposed project will make the following improvements to the Town's sewer collection system:

Gravity Sewer Collection System:

Replacement of approximately 10 manholes and 44 clean-out caps; rehabilitation of 46 manholes, one (1) service lateral, and 15 manhole point repairs.

Pump Station No.1:

Replacement of pressure gauges and pump rail brackets; rehabilitation of wetwell to include trash, solids, and grease removal, exterior sandblasting, and painting; and installation of trash basket, backflow preventer with hotbox, sump pump in the meter vault, and SCADA system.

Pump Station No.2:

Replacement of pressure gauges and pump rail brackets; rehabilitation of wetwell to include solids and grease removal, exterior sandblasting, and painting; and installation of corrosion resistant insect/bird screen, backflow preventer with hotbox, and SCADA system.

Pump Station No.3:

Replacement of pressure gauges and pump rail brackets; rehabilitation of wetwell to include trash, solids, and grease removal, exterior sandblasting, and painting; rehabilitation of valve vault; and installation of backflow preventer with hotbox, on-site generator, and SCADA system.

Pump Station No.4:

Replacement of pressure gauges; rehabilitation of wetwell; installation of non-freeze potable water hydrant, backflow preventer with hotbox, and SCADA system.

Pump Station No.5:

Replacement of pressure gauges; and installation of SCADA system.

Portable Generator:

Trailer mounted portable generator to be used as emergency backup power for pump station Nos. 2 and 4.

The above named applicant will receive funding assistance from the State Revolving Fund. The North Carolina Division of Water Infrastructure (Division) has conducted a review of the project in accordance with the NCGS §159G-38. The Division has determined that this project is below the minor construction activities threshold outlined in 15A NCAC 01C .0408; therefore, the project is exempt from inter-agency review, and the preparation of additional environmental documents is not required.

This determination shall become effective upon its distribution by the Division and will be available on the Division's website (<https://deq.nc.gov/about/divisions/water-infrastructure/division-water-infrastructure/environmental-documents>). This determination can be revoked at any time adverse information is made available. The documentation to support this decision will be on file with the North Carolina Department of Environmental Quality, Division of Water Infrastructure, and is available for public scrutiny upon request.
