Comment: Town of Falcon has about 273 people as its population from the 2016 updated census. The town informed me that have one truck and one part time employee who takes on all this work once per week. Disposal taxes support maintenance of the truck they have- David Hance - November 2019.

Question # 43- Recycling: The town collects limited recyclables: They only collect aluminium and plastic bottles from citizens on what they describe on a voluntary basis. They do not record tonnages since they cannot weigh these and have not done so. This is not budgeted with a line item for it. (email from town on 8/20/2019 -DH).

Question # 65- Reporting of MSW and FCA not done by this town: They have not reported tons nor any budget or cost information for MSW or for recycling services. They appear not to be tracking it, They told me there is no separate budget for any of this. (email from town on 8/20/2019 -DH).

****Comment: It makes little sense for Falcon to continue to provide such MSW or recycling services. It would be far better if staffs convinced them to allow the county to take over this work and much more cost effective for its citizens .. If the town will no make changes, then they need to start collecting fiscal and tonnage information on solid waste and recycling they do (DH- 11-5-2019)
