HUD-CDBG Program Purpose

- Established with Housing and Community
 Development Act of 1974
 - Federal Program implemented by US Housing and Urban Development (HUD)
 - Goal development of viable communities by providing principally persons of Low and Moderate Income (LMI):
 - Decent housing
 - Suitable living environment
 - Expanded economic opportunities

HUD-CDBG Program Purpose

- Three National Objectives: (must meet one)
 - Benefit persons of Low and Moderate Income (LMI)

Or...

- Prevent or Eliminate Slums and Urban Blight Or...
- Meet an Urgent Community Development Need

HUD-CDBG Program Purpose

- The federal funds are split between direct appropriations to metropolitan areas, called "entitlement communities", and
- Funds appropriated to the states for distribution into less populated areas, "nonentitlement communities"

Entitlement Area Funding

- Nationally, \$2.3 billion goes directly to metropolitan cities and urban counties
- In NC, the cities of Asheville, Burlington, Cary, Chapel Hill, Charlotte, Concord, Durham, Fayetteville, Gastonia, Goldsboro, Greensboro, Greenville, Hickory, High Point, Jacksonville, Kannapolis, Lenoir, Morganton, Raleigh, Rocky Mount, Salisbury, Wilmington, and Winston-Salem receive these funds directly, as do Wake, Mecklenburg and Cumberland Counties

Non-Entitlement Funding

- Non-Entitlement (est. 1981) States to administer
 - Each State develops funding priorities and criteria for selecting projects
 - ~\$1 billion (average of \$20 million/state) in FY 2013
 - NC share \$44 million (2X) 2nd/3rd highest in nation
 - Based on Population and Need
 - NC rural low income communities with high need

Who are Non-Entitlement Communities?

- Units of General Local Government
- Cities with populations of less than 50,000
- Counties with populations of less than 200,000
 - In NC, all counties except Wake, Mecklenburg, and Cumberland

NC CDBG Program – History

- HUD contracts with the NC Department of Commerce's Division of Community Assistance (DCA) to administer the funds
- Funding and allocation priorities varied over time, and was allocated through the budget bill to several different programs

NC CDBG Program Prior to 2013

HUD Concerns with Present Program

- HUD (NC regional office) concerns
 - Third slowest in the nation in expending funds
 - Only Texas and California are slower
 - LMI determination stricter than federally required
 - Environmental review can be streamlined

Legislative Changes 2013

- Recognized North Carolina priorities as Infrastructure and Economic Development
- Moved administration of infrastructure to NC Department of Environment and Natural Resources
- May be limited to Tier 1 and Tier 2 counties
- State rules cannot exceed federal requirements

NC CDBG Program – 2013 Changes

- NCDENR will administer the infrastructure (\$26 million) portion of the CDBG funds
 - Either fund in full or partner with other state and federal loan programs to assist with water and sewer costs in small, low income communities
 - Department of Commerce will continue to administer the Economic Development portion (\$16 million)

National and State Objectives

- National (HUD) Objective
 - Benefit Persons or Areas of >51 % LMI
 - A total of 70% of NC's funding must benefit LMI
 - Coordination with Commerce CDBG-Economic Development will be important
- State Infrastructure Objective
 - Improve quality of life, public and environmental health, and economic vitality for LMI communities by correcting water and wastewater infrastructure problems

CDBG-I Eligible Applicants

- Only Units of General Local Government (excludes water/sewer districts, other single purpose governmental units)
- Only Non-entitlement Areas
 - Cities with populations of less than 50,000
 - Counties with populations of less than 200,000

CDBG-I Program Limits

- Limitations
 - No minimum grants
 - Maximum of \$3.0 million over three years, consistent with GS 159G
 - No open contracts not in compliance
- Application Intakes: 2 or 3 per year

Proposed Applicant Priority Criteria

- Threshold Criteria 51% LMI minimum
- Competitive with three levels of proposed priority points
 - Criterion 1 Economic Need
 - Criterion 2 Severity of Need
 - Criterion 3 System Management

Proposed Applicant Priority Criteria

- Criterion 1 Economic Need such as <u>percent of LMI</u> population in the area to be served, the <u>poverty rate</u>, and the amount of the water and sewer bill relative to the median household income of the area
- Criterion 2 Severity of Need systems under <u>moratoria or</u> <u>special orders by consent</u>, with high water loss, high inflow and infiltration, or areas with failing septic systems, contaminated or dry wells
- Criterion 3 System Management good operating ratios, presence of <u>Capital Improvement Plans</u> and/or Asset Management Plans

Other Considerations

- Other considerations may not receive points, but can be taken into consideration
 - Geographical distribution of projects in the state
 - Presence of matching funds in the project
 - Readiness to proceed with the project

- November 5, 2014 is the federal deadline to have all funds committed
- If all funds are awarded in the first round of grant making, there will not be a second round for Federal FY 2013 funds
