The following report is the first quarterly report regarding the implementation of SL 2024-44 Sections 5.1(d) and 5.1(e)

**SL 2024-44 5.1(d) – September 1, 2024, Report**

In accordance with SL 2024-44 the Director of the Division of Water Resources and the Chair of the Environmental Management Commission submitted to Katie Butler, Region 4 Water Division Director of the U.S. Environmental Protection Agency (EPA) a letter on July 31, 2024, requesting EPA's comments on rule modifications proposed in the SL 2024-44 Section 5.1(d). As of September 1, 2024, EPA has not responded.

**SL 2024-44 5.1(e) – September 1, 2024, Report**

In accordance with SL 2024-44 the Director of the Collaboratory appointed 5 members, listed below, to the work group who are actively or have worked in the fields of environmental regulation, wastewater regulation, water quality regulation, and wastewater treatment regulation. The Department in conjunction with the Collaboratory held the initial meeting of the Wastewater General Permit Working Group on August 26, 2024. Director Butler,

On July 8, 2024, Senate Bill 802 (Session Law 2024-44) was signed into law by Governor Cooper. Session Law 2024-44 requires that by August 1, 2024, the Department of Environmental Quality and the North Carolina Environmental Management Commission:

“...develop and submit to the United States Environmental Protection Agency for USEPA's approval draft rules that establish methodologies and permitting requirements for the discharge of treated domestic wastewaters with low risk following site-specific criteria to surface waters of the State, including wetlands, perennial streams, and unnamed tributaries of named and classified streams and intermittent streams or drainage courses where the 7Q10 flow or 30Q2 flow of the receiving water is estimated to be low flow or zero flow, or under certain conditions non-existent, as determined by the United States Geological Survey (USGS).”

The Session Law 2024-44 Section 5 further states:

"Within 20 days of the date USEPA approves the draft rules submitted pursuant to this subsection, the Commission shall initiate the process for temporary and permanent rules pursuant to Chapter 150B of the General Statutes."

In North Carolina, temporary rules require a public comment period and a public hearing, and permanent rules require public comment period with a potential public hearing upon a public request. GS 150B is our Administrative Procedures Act. While Session Law 2024-44 stipulates what is in the "draft rule" to be reviewed by EPA, it does not stipulate the language required in the temporary or permanent rule. It is our understanding that the statute is intended to get comments from USEPA before rulemaking begins and public input is received through the rulemaking process.

Realizing the August 1, 2024, timeline given in SL 2024-44 Section 5.1.(a) through (g) would not be feasible for submitting draft rules to EPA for approval, the Environmental Management

Commission (EMC) at its July 11, 2024, meeting selected to submit a letter containing draft rule concept consistent with Session Law 2024-44 for EPA's review. Attached you will find the draft rule concept incorporating permitting requirements and Section Law 2024-44.


We request that EPA Region 4 review the proposed draft rule concept and provide a written response as to whether such amendments to Rule 15A NCAC 02B .0206 would comply with federal law related to the Clean Water Act and the requirements that states must comply with to maintain an EPA approved NPDES program.

The EMC and DEQ look forward to your comments regarding this important matter.

## Working Group Biographies

### **Chad VonCannon - *wastewater treatment regulation / wastewater regulation***
