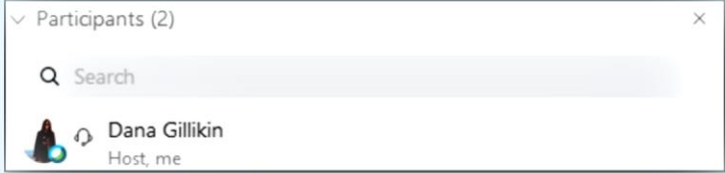


AUDIO TROUBLESHOOTING

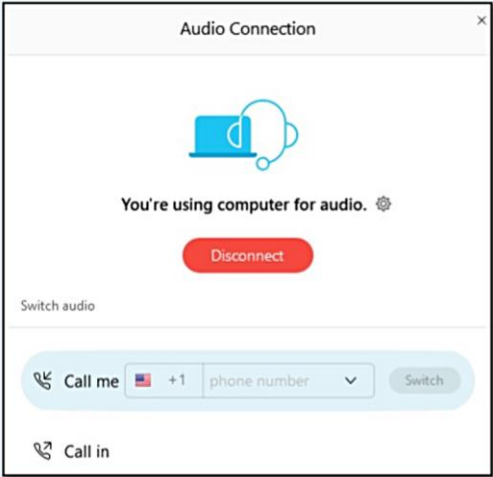
If you are not hearing any sound, try the following:
