PROCLAMATION

<u>RE: SCUP – RECREATIONAL – NORTH OF CAPE HATTERAS – INCREASES MINIMUM</u> <u>SIZE LIMIT</u>

This proclamation supersedes Proclamation FF-11-2015, dated March 10, 2015. It increases the minimum size limit for the recreational scup fishery effective at 12:01 A.M., April 1, 2022.

Kathy B. Rawls, Director, Division of Marine Fisheries, hereby announces that effective at **12:01 A.M., April 1, 2022**, the following restrictions will apply to the recreational scup fishery in Coastal Fishing waters which includes the Atlantic Ocean <u>0 to 3 miles north of Cape</u> <u>Hatteras (35° 15.3'N. Latitude):</u>

I. SIZE LIMIT

It is unlawful to possess scup less than 9 inches total length.

II. POSSESSION LIMIT

It is unlawful to possess more than 50 scup per person per day.

III. GENERAL INFORMATION

- A. This proclamation is issued under the authority of N.C.G.S. 113-134; 113-134.1; 113-170.4; 113-170.5; 113-182; 113-182.1; 113-221; 143B-289.52 and N.C. Marine Fisheries Commission Rules 15A NCAC 03H .0103; and 03M .0512.
- B. It is unlawful to violate the provisions of any proclamation issued by the Fisheries Director under their delegated authority pursuant to N.C. Marine Fisheries Commission Rule 15A NCAC 03H .0103.
- C. The intent of this proclamation is to maintain North Carolina's compliance with the requirements of the joint Mid-Atlantic Fisheries Management Council – Atlantic States Marine Fisheries Commission Summer Flounder, Scup and Black Sea Bass Fisheries Management Plan under the authority of N.C. Marine Fisheries Commission Rule.
- D. In accordance with N.C. General Statute 113-221.1(c) All persons who may be affected by proclamations issued by the Fisheries Director are under a duty to keep themselves informed of current proclamations.
