PROCLAMATION

RE: SHAD - COMMERCIAL AND RECREATIONAL - TEMPORARY SUSPENSION OF RULES

This proclamation sets the 2023 commercial and recreational seasons and harvest restrictions for the taking of American shad and hickory shad in Coastal and Joint Fishing waters.

Kathy B. Rawls, Director, Division of Marine Fisheries, hereby announces that effective at **12:01 A.M.**, **Sunday, January 1, 2023**, the following restrictions will apply to the taking of American shad and hickory shad for commercial and recreational purposes:

I. TEMPORARY SUSPENSION OF RULES

A. The following portion of N.C. Marine Fisheries Commission Rule 15A NCAC 03Q .0107 is suspended:

Paragraph (4) which reads:

(4) Shad: It is unlawful to possess more than 10 American shad or hickory shad, in the aggregate, per person per day taken by hook-and-line.

II. <u>HARVEST RESTRICTIONS-COMMERCIAL</u> (SEE SECTION IV. FOR ADDITIONAL <u>RESTRICTIONS</u>)

A. CAPE FEAR RIVER AND TRIBUTARIES

- 1. It is unlawful to possess American shad for commercial purposes prior to 12:01 A.M. Monday, February 20, 2023, and after 11:59 P.M. Tuesday, April 11, 2023.
- 2. It is unlawful to possess hickory shad for commercial purposes prior to 12:01 A.M., Sunday, January 1, 2023, and after 11:59 P.M., Friday, April 14, 2023.

B. ATLANTIC OCEAN

1. It is unlawful to possess hickory shad for commercial purposes prior to 12:01 A.M., Sunday, January 1, 2023, and after 11:59 P.M., Friday, April 14, 2023.

C. ALL OTHER INTERNAL COASTAL AND JOINT FISHING WATERS

- 1. It is unlawful to possess American shad for commercial purposes prior to 12:01 A.M. Wednesday, February 15, 2023, and after 11:59 P.M., Friday, April 14, 2023.
- 2. It is unlawful to possess hickory shad for commercial purposes prior to 12:01 A.M., Sunday, January 1, 2023, and after 11:59 P.M., Friday, April 14, 2023.

III. HARVEST RESTRICTIONS-RECREATIONAL

A. PAMLICO AND PUNGO RIVERS AND TRIBUTARIES

- 1. It is unlawful to possess more than ten (10) American shad or hickory shad, in the aggregate, per person per day taken by hook-and-line or for recreational purposes.
- 2. It is unlawful to possess American shad or hickory shad for recreational purposes by any method except hook-and-line after 11:59 P.M., Friday, April 14, 2023.

B. CAPE FEAR RIVER AND TRIBUTARIES

1. It is unlawful to possess more than ten (10) American shad or hickory shad in the aggregate, per person per day taken by hook-and-line or for recreational purposes and only five (5) of the ten (10) may be an American shad.

2. It is unlawful to possess American shad or hickory shad for recreational purposes by any method except hook-and-line after 11:59 P.M., Friday, April 14, 2023.

C. ATLANTIC OCEAN

- 1. It is unlawful to possess more than ten (10) hickory shad per person per day taken by hook-and-line or for recreational purposes.
- 2. It is unlawful to possess hickory shad for recreational purposes by any method except hook-and-line after 11:59 P.M., Friday, April 14, 2023.

D. ALL OTHER INTERNAL COASTAL AND JOINT FISHING WATERS

- 1. It is unlawful to possess more than ten (10) American shad or hickory shad in the aggregate, per person per day taken by hook-and-line or for recreational purposes and only one (1) of the ten (10) may be an American shad.
- 2. It is unlawful to possess American shad or hickory shad for recreational purposes by any method except hook-and-line after 11:59 P.M., Friday, April 14, 2023.

IV. GENERAL INFORMATION

- A. This proclamation is issued under the authority of N.C.G.S. 113-134; 113-134.1; 113-170.4; 113-170.5; 113-181; 113-182; 113-182.1 113-221.1; 143B-289.52 and N.C. Marine Fisheries Commission Rules 15A NCAC 03H .0103 and 03M .0512.
- B. It is unlawful to violate the provisions of any proclamation issued by the Fisheries Director under their delegated authority pursuant to N.C. Marine Fisheries Commission Rule 15A NCAC 03H .0103.
- C. In accordance with N.C. Marine Fisheries Commission Rule 15A NCAC 03M .0519, it is unlawful to possess American shad taken from the Atlantic Ocean.
- D. In accordance with N.C. General Statute 113-221.1(c), all persons who may be affected by proclamations issued by the Fisheries Director are under a duty to keep themselves informed of current proclamations.
- E. The intent of this proclamation is to implement the provisions of the N.C. American Shad Sustainable Fishery Plan as part of Amendment 3 to the Atlantic States Marine Fisheries Commission Interstate Fishery Management Plan for Shad and River Herring.
- F. Proclamation <u>M-3-2014</u>, dated February 3, 2014 prohibits the setting of gill nets in the Joint Fishing Waters of the state from midnight on Friday to midnight on Sunday each week. Portions of Albemarle and Currituck sounds are exempt from that provision in accordance with Supplement A to the 2012 Spotted Seatrout Fishery Management Plan.

- H. Check current proclamations for additional gill net restrictions for specific management areas. The use of all gill nets is prohibited upstream of the ferry lines from the Bayview Ferry to Aurora Ferry on the Pamlico River and the Minnesott Beach Ferry to Cherry Branch Ferry on the Neuse River (refer to <u>M-6-2019</u> for more information). All other existing gill net rules and proclamations remain in effect.
