**PROCLAMATION**

**RE: RESEARCH SANCTUARY- ATLANTIC OCEAN – DARE COUNTY – COASTAL AND HYDRAULICS LABORATORY, FIELD RESEARCH FACILITY**

**This proclamation establishes a closure to recreational and commercial trawls, nets, longlines, and seines in a Research Sanctuary area in the Atlantic Ocean off the Coastal and Hydraulics Laboratory, Field Research Facility located near the town of Duck, North Carolina.**

Kathy B. Rawls, Director, Division of Marine Fisheries, hereby announces that effective at **12:00 A.M., May 7, 2023**, in the area described below, **the following restrictions apply:**

**I. AREA DESCRIPTION (See Map)**

**ATLANTIC OCEAN - DARE COUNTY**

Behind Field Research Facility, surrounding the pier in the Atlantic Ocean near the town of Duck in Dare County, North Carolina. The total area is approximately 349.15 acres in size and is delineated by poles with signs nearshore and buoys with markings offshore as shown on the attached map. The location of the poles and buoys are as follows:

Nearshore (NW corner)	36° 11.2010' N	75° 45.1150' W
Buoy (NE corner)	36° 11.4560' N	75° 44.3020' W
Buoy (SE corner)	36° 10.8820' N	75° 44.0410' W
Nearshore (SW corner)	36° 10.6780' N	75° 44.8820' W


**II. RESTRICTIONS**

It is unlawful to use recreational and commercial trawls, nets, longlines, and seines in the area described in Section I.

**IV. GENERAL INFORMATION**

- A. This proclamation is issued under the authority of N.C.G.S. 113-134; 113-134.1; 13-170.4; 113-170.5; 113-182; 113-221.1; 143B-289.52; and N.C. Marine Fisheries Commission Rules 15A NCAC 03H .0103 and 03I .0109.
- B. It is unlawful to violate provisions of any proclamation issued by the Fisheries Director under their delegated authority pursuant to N.C. Marine Fisheries Commission Rule 15A NCAC 03H .0103.
- C. In accordance with N.C. Marine Fisheries Commission Rule 15A NCAC 03J .0202 it is unlawful to use trawls within one-half mile of the beach between the Virginia line and Oregon Inlet in the Atlantic Ocean.
- D. This area is used by the Field Research Facility established in 1977 by the U.S. Army Corps of Engineers and is part of the Coastal and Hydraulics Laboratory. It is an internationally recognized coastal observatory and instruments at the facility constantly record the changing waves, winds, tides, and currents.

- F. In accordance with N.C. General Statute 113-221.1(c) All persons who may be affected by proclamations issued by the Fisheries Director are under a duty to keep themselves informed of current proclamations.
- G. In accordance with N.C. Marine Fisheries Commission Rule 15A NCAC 03I .0109, any closure or restriction in the Research Sanctuary shall be for no more than one year, subject to renewal at the discretion of the Fisheries Director.
- H. **This proclamation establishes a closure to recreational and commercial trawls, nets, longlines, and seines in a Research Sanctuary area in the Atlantic Ocean off the Coastal and Hydraulics Laboratory, Field Research Facility located near the town of Duck, North Carolina.**
