PROCLAMATION

RE: GILL NETS – NEWPORT RIVER USER CONFLICT RESOLUTION AREA

This proclamation supersedes proclamation M-35-2014, dated October 17, 2014. This proclamation maintains attendance requirement for gill nets with a stretched mesh length less than 4-inches in the Newport River User Conflict Resolution Area in accordance with N.C. Marine Fisheries Commission Rule 031.0122.

Kathy B. Rawls, Director, Division of Marine Fisheries, hereby announces that effective **7:00 A.M. April 15, 2024 the following restrictions shall apply to the use of gill nets in the following area:**

I. AREA – CARTERET COUNTY

Newport River All waters in the Newport River waterbody south and west of a line starting at 34° 44.8249' N, 76° 42.1716' W, heading east to a point at 34° 44.9627' N, 76° 40.6491' W, then heading south along the western border of the Intracoastal Waterway to a point at 34° 43.2600' N, 76° 41.5534' W at the intersection of the IWW and the Highway 70 bridge to Radio Island (See Map).

II. GEAR RESTRICTIONS

It shall be unlawful to fail to attend gill nets with a stretched mesh length less than 4 inches at all times from 7:00 A.M. to 7:00 P.M. in the area described in Section I.

III. GENERAL INFORMATION

- A. This proclamation is issued under the authority of N.C.G.S. 113-134; 113-170.4; 113-170.5; 113-182; 113-221.1; 143B-289.52 and N.C. Fisheries Commission Rules 15A NCAC 3H .0103, 03I .0122, and 3J .0103.
- B. It is unlawful to violate provisions of any proclamation issued by the Fisheries Director under their delegated authority pursuant to N.C. Marine Fisheries Rule 15A NCAC 3H .0103.
- C. In accordance with N.C. General Statute 113-221(f) and 113-221.1(c) all persons who may be affected by rules and proclamations issued by the Fisheries Director are under a duty to keep themselves informed of current rules and proclamations. Multiple rules and proclamations regulating a fishery, species, gear, etc. may be in effect concurrently.
- D. All other existing gill net rules and proclamations remain in effect. See <u>https://deq.nc.gov/about/divisions/marine-fisheries/rules-proclamations-and-size-and-bag-limits/fisheries-management-proclamations#currentprocs</u> to refer to those M-type proclamations for gill net regulations that may be effective in the areas covered by this proclamation.
- E. The intent of this proclamation is to maintain regulations that address user conflicts in the area specific to the mortality of red drum captured in gill nets.
