PROCLAMATION

RE: COBIA - COMMERCIAL AND RECREATIONAL - COASTAL AND JOINT FISHING WATERS

This proclamation supersedes proclamation FF-52-2024 dated December 12, 2024. This proclamation opens the commercial cobia fishery beginning at 12:01 A.M. on January 1, 2025. The season for the recreational harvest of cobia will re-open at 12:01 A.M. on May 1, 2025.

Kathy B. Rawls, Director, Division of Marine Fisheries, hereby announces that effective **at 12:01 A.M., January 1, 2025**, the following restrictions will apply to the cobia fishery in Coastal and Joint Fishing Waters:

I. COMMERCIAL SIZE AND HARVEST LIMIT

- A. It shall be unlawful to possess cobia less than 36 inches fork length in a commercial operation.
- B. It shall be unlawful to possess more than two (2) cobia per person per day or six (6) per vessel per day, whichever is more restrictive in a commercial operation.
- C. It shall be unlawful to possess a commercial and recreational limit of cobia on the same vessel.
- D. The commercial fishery will close by proclamation once the quota is met or projected to be met, or December 31, 2025, whichever occurs first.

II. RECREATIONAL SEASON, HARVEST, VESSEL, AND SIZE LIMIT

A. RECREATIONAL SIZE LIMIT, POSSESSION LIMIT, AND SEASON

- 1. The season for the recreational harvest of cobia will be May 1, 2025 December 31, 2025. It shall be unlawful to possess cobia outside of this season.
- 2. It shall be unlawful to possess for a recreational purpose cobia less than **36 inches fork length**.
- 3. It shall be unlawful to possess for a recreational purpose more than **one** (1) cobia per person per day (See section B and C below for season and vessel limits).

B. <u>PRIVATE VESSEL LIMITS for Recreational Purpose (All vessels not engaged in a For-Hire Vessel operation)</u>

From May 1 – June 30, it shall be unlawful to possess more than two (2) cobia per vessel per day if two or more persons are onboard or one (1) cobia per person per day, if there is only one person on board.

- 2. From July 1 December 31, it shall be unlawful to possess more than one (1) cobia per vessel per day.
- C. <u>FOR-HIRE VESSEL</u> (While engaged in a For-Hire Vessel operation as defined by G.S 113-174)
 - From May 1 December 31, it shall be unlawful to possess more than four (4) cobia per vessel per day or (1) cobia per person per day, if fewer than four (4) people are on board.

III. GENERAL INFORMATION

- A. This proclamation is issued under the authority of N.C.G.S. 113-134; 113.134.1; 113-170.4; 113-170.5; 113-182; 113-182.1; 113-221.1; 143B-289.52; and N.C. Marine Fisheries Commission Rules 15A NCAC 03H .0103 and 03M .0512.
- B. It is unlawful to violate the provisions of any proclamation issued by the Fisheries Director under their delegated authority pursuant to N.C. Marine Fisheries Commission Rule 15A NCAC 03H.0103.
- C. Fishermen are encouraged to return all cobia not meeting harvest requirements to the water in a manner that ensures that highest likelihood of survival.
- D. The intent of this proclamation is to manage the commercial and recreational fishery for cobia in Coastal Fishing Waters consistent with the Atlantic States Marine Fisheries Commission's Interstate Cobia Fishery Management Plan.

- G. This proclamation opens the commercial cobia fishery beginning at 12:01 A.M. on January 1, 2025. The season for the recreational harvest of cobia will re-open at 12:01 A.M. on May 1, 2025.
