This application is to be completed and signed by individuals applying for a Block of 10 Ten-Day Coastal Recreational Fishing Licenses. Businesses requesting a block of licenses must have the Responsible Party (business agent) complete and sign the application. The Responsible Party is the person who coordinates, supervises, or otherwise directs operations of a business entity, such as a corporate officer or executive-level supervisor of business operations and/or is the person responsible for use of the issued License in compliance with applicable laws and regulations. Individuals applying for a license for another under the authority of Power of Attorney must submit a PHOTOCOPY of the Power of Attorney and current picture identification.

## Eligibility:

The Coastal Recreational Fishing License is required for any angler engaged in recreational harvest of finfish in the coastal fishing waters of the state. The Block of 10 Ten-Day Coastal Recreational Fishing Licenses can only be sold for use on vessels that have a length of 23 feet or greater and is registered with North Carolina Wildlife Resources Commission or US Documented vessels. The Block of 10 Ten-Day Coastal Recreational Fishing Licenses can only be sold for use on vessels that do not hold a Blanket For-Hire Vessel Coastal Recreational Fishing License.

Provide a PHOTOCOPY of one of the following current picture identifications of responsible Party and/or Vessel Master:

- Driver's License; or
- Passport; or
- Resident Alien Card (green card)
- State Identification (issued by DMV); or
- Military Identification; or

If you are applying as a business, you must provide:

- If incorporated, a PHOTOCOPY of Articles of Incorporation and list of current corporate holders.
- If written agreement partnership, a PHOTOCOPY of written partnership agreement.
- If not incorporated or written partnership, a PHOTOCOPY of current assumed name statement, filed with Clerk of Court in the business county, and a PHOTOCOPY of business privilege tax certificates, if applicable.


## A Block of 10 Ten-Day Coastal Recreational Fishing Licenses Application:

- Complete all the applicable Participant Information, including Participant Identification number. This number is listed to the right of the word Participant \# on your license. If you do not currently have a license with DMF, please leave this box blank.
- All surveys must be completed.
- Sign the application.
- Complete the NC DMF License Certification Form. It must be notarized if applying for a new license.
- Provide a PHOTOCOPY of valid NC Wildlife Resources Commission vessel registration or U.S. Coast Guard Vessel documentation.

Fees:

- See Commercial License and Permit Fee Sheet. If you need assistance, please contact any NC DMF License Office or call (252) 726-7021 or (800) 682-2632, There is a $\$ 5.00$ fee for replacing current/valid license.
- Method of payment: Personal check, money order or Cashier check. Make payable to North Carolina Division of Marine Fisheries. There will be a $\$ 25.00$ service charge for returned checks.

You are required to notify the Division of Marine Fisheries of any address or residency changes within 30 days. Incomplete applications submitted without required documentation will be deemed incomplete and returned to you unprocessed.

## BLOCK OF 10 TEN-DAY COASTAL RECREATIONAL FISHING LICENSES (CRFL)

- The purchase of a block of 10 Ten-Day CRFLs allows the vessel owner to issue ten-day Coastal Recreational Fishing Licenses to anglers aboard their vessel.
- CRFL licenses can only be used while fishing aboard the vessel for which they were issued.
- Vessel owners are responsible for completing all information on the license.
- The purchase of a block of 10 Ten-Day CRFLs are only for North Carolina registered or US Documented vessels.
- The vessel must be over 23 feet in length.
- Vessel owners are responsible for returning all used licenses to the Division of Marine Fisheries in the postage paid envelope within 10 days of the expiration of the license.
- Blocks of licenses are valid for two years from the date of purchase. All unused licenses must be returned to the Division of Marine Fisheries within 10 days of the two-year expiration.
- Lost or stolen licenses can be replaced for a fee of $\$ 5.00$.
