## **PROCLAMATION**

### **RE: SHELLFISH POLLUTED AREA**

Kathy B. Rawls, Director, Division of Marine Fisheries, upon the recommendation of Betsey Tilson, M.D., M.P.H., State Health Director, Department of Health and Human Services, hereby announces that the following change in a shellfish harvesting area will take effect at sunrise, Friday, July 7, 2023.

All those waters in Brunswick County will return to the status in existence immediately prior to the June 21 and July 6, 2023 temporary closures, **except the following which remains closed:** 

# **BRUNSWICK COUNTY**

<u>All those waters</u> bordered on the east by a line beginning at a point 33° 54.2904′ N - 78° 23.6416′ W on the mainland near the Bricklanding Road Public Boat Ramp and IWW Beacon "84"; running southerly to a point 33° 54.1932′ N - 78° 23.6426′ W on Ocean Isle Beach near Ferry Landing Park; and bordered on the west by the South Carolina State Line, to include Tubbs Inlet.

# The following also remains closed:

## **NEW HANOVER / ONSLOW / CARTERET / PAMLICO COUNTIES**

<u>All those waters from the Intracoastal Waterway to the mainland</u> between IWW Marker "129" (34° 11.5153'N - 77° 49.5764' W) near Shinn Creek and IWW Marker "141" (34° 07.7515'N - 77° 51.9560' W) near Peden Point, to include the Intracoastal Waterway.

<u>Queens Creek - All those waters</u> in Queens Creek upstream of a straight line across the mouth, beginning at a point 34° 39.8479′N - 77° 09.1171′ W on the west shore; running northeasterly to a point 34° 40.2031′N - 77° 08.4408′ W on the east shore near the State Park Boat Ramp.

<u>Newport River – All those waters in Newport River</u> upstream of the Highway 70 High Rise Bridge and the Morehead-Beaufort Causeway, to include all tributaries and Core Creek.

North River - All those waters in North River upstream of a straight line beginning at a point 34° 42.1302′ N - 76° 36.0815′ W at the permanent closure line near Beacon "5"; running northeasterly to a point 34° 43.2724′ N - 76° 34.5238′ W on the mainland at the Harker's Island Bridge at The Straits, to include Ward Creek.

<u>Oyster Creek - All those waters in Oyster Creek</u> upstream of a straight line across the mouth, beginning at a point 34° 48.8185' N - 76° 26.9761' W on the west shore; running northeasterly to a point 34° 48.9768' N - 76° 26.6340' W on the east shore.

Brett Bay - All those waters in Brett Bay upstream of a straight line from Piney Point to King Point.

<u>Nelson Bay - All those waters in Nelson Bay</u> upstream of a line from Drum Point to the northern tip of Fulchers Creek.

<u>All those waters</u> in Neuse River near Oriental bounded by a line beginning at Maw Point running southeasterly to Fl. Beacon "NR"; thence running southwesterly to a point 34° 58.3128' N - 76° 43.7327' W in the river, thence running northwesterly to a point 34° 59.5689' N - 76° 45.3295' W on the shoreline near Dawson Creek, to include Broad Creek.

<u>Bay River - All those waters in Bay River</u> upstream of a line beginning at a point 35° 10.7969' N - 76° 36.7833' W on the north shore near Spencer Point, running southerly to a point 35° 09.6952' N - 76° 36.6683' W on the south shore.

#### **GENERAL INFORMATION:**

- A. This proclamation is issued under the authority of N.C.G.S. 113-170.4; 113-170.5; 113-182; 113-221.1; 143B-289.52 and N.C. Marine Fisheries Commission Rules 15A NCAC 03H .0103 and 03K .0101.
- B. It is unlawful to violate the provisions of any proclamation issued by the N.C. Fisheries Director under their delegated authority pursuant to N.C. Marine Fisheries Commission Rule 15A NCAC 03H .0103.
- C. In accordance with N.C. General Statute 113-221.1(c) all persons who may be affected by proclamations issued by the Fisheries Director are under a duty to keep themselves informed of current proclamations.
- D. This proclamation returns the following area to normal closure boundaries: Lockwoods Folly River.
- E. This opening is due to satisfactory bacteriological sampling results.
