Dear Charles:

Our TRIANGLE QUARRY mining permit prohibits Wake Stone from shipping material on Saturdays after 1:00 pm. This provision was added to our permit in order to insure that citizens utilizing Reedy Creek State Park were able to enjoy the park without the interference of truck traffic and other quarry operations.


Reedy Creek State Park has been closed since September 6, 1996 because of damage caused by Hurricane Fran. I believe the park will be closed for some time to come.

The Nello Teer Company is presently working on an special repair to the Raleigh Outer Loop near the RDU Airport -- a job that requires the shipment of 60,000 tons of ABC within a two month period of time. Because of the heavy rains during the past two months, the job is running well behind the anticipated schedule. Teer Company has asked us if we would be able to stay later than 1:00 pm on Saturdays in order to accommodate their needs. We have explained our permit restrictions to them, however with the Park not in operation at this time, we would like permission to ship aggregates to this NC DOT job until 5:00 on Saturdays. This request, and related permission, would expire when the park reopens or when Teer completes the repair, whichever comes first.
