8/8/2018: 15% credit release was scheduled; however, due to IRT concerns on some of the wetland mitigation areas, only half of the scheduled release was approved, leaving 0.645 credits on hold.

1/16/2019: During the review of Year 4 monitoring report, DMS discovered that the schedule of credit release was incorrect from what was included and approved in the final mitigation plan. The credit release schedule has been adjusted for the unreleased credits from 8/8/2018.

4/21/2020: DMS requested the scheduled credit release plus the 0.645 wetland credits (7.50% of total project) on hold since 2018. The IRT approved the current schedule release of 15% but the remaining 7.50% from 2018 will remain on hold due to continued concerns related to the wetland areas not performing and gauge issues.

2/25/2021: DMS has marked 1.50 wetland credits at risk on this project. Due to the possibility of reduced wetland credits on this project, DMS is requesting no release for the Year 6 monitoring cycle. This also includes the 0.645 credits (7.50%) on hold from 2018.

2/9/2022: DMS plans to monitor this project for an additional year and is not requesting a release of any wetland credits for the last monitoring cycle. Currently, there are 1.935 unreleased non-riparian wetland credits remaining on this project. DMS plans to recommend this project for closeout next year along with a site visit to review the project.
