
## Why should you have your well sampled?

Chemours is required to sample private drinking water wells to find GenX/PFAS contamination coming from their facility and provide replacement drinking water supplies. DEQ urges eligible residents to have their wells tested to find and reduce exposure to PFAS contamination.

Sampling is being conducted in a step-out plan. If a site is found to be contaminated, Chemours is required to step-out to find the edge of contamination. If you are close to the sampling area as indicated in this map, please call to get your well tested.

**Call Chemours (910) 678-1101**

Please leave a voice message detailing the reason for the call, and include your name, phone number and address. This record will allow Chemours to contact you in the future if sampling expands to your area.



Please note: Parsons is the only contractor authorized to conduct sampling on behalf of Chemours. Results will be mailed to your house.

## What are the alternative drinking water options and how do you qualify for them?

Chemours will provide you with an alternate drinking water option depending on the level of PFAS found in your private well water:

- GenX 10ppt or above: If GenX (HFPO-DA) is found at 10ppt or greater, you qualify for a whole-building Granular Activated Carbon (GAC) filtration system, or an under-sink Reverse Osmosis (RO) system at every kitchen and bathroom sink. If feasible, you may be connected to the nearest public utility water line. If a public water connection is installed, Chemours is required to pay water bills for 20 years
- If any one of the 12 PFAS listed on Attachment C are found at 10ppt or greater, or a combination of the compounds are found at 70ppt or greater, your home qualifies for three under-sink RO systems. If feasible, a connection to the nearest public utility water line will be made. However, Chemours is NOT required to pay for these water bills.

**Note: Installed filtration systems will be maintained by Chemours for a minimum of 20 years or until the PFAS level in your water is no longer above the action levels.**

## When do you get bottled water?

If your preliminary results qualify for alternate drinking water, you will receive temporary drinking water via a bottled water delivery, or a voucher card loaded with \$225 per quarter (\$75/month).

**IMPORTANT: Bottled water service or voucher cards will be provided until a permanent alternate water solution is installed for your home.**
