Changes to the Express Review Program

Due to a reduction of staff, the DWQ Central Office will no longer be offering the following express review services: 401 water quality certifications, non-404 jurisdictional general permit, riparian buffer authorizations or minor variances, stormwater management plan review/approval, stream origin or intermittent/perennial determinations, or non-404 wetland determinations. All of the services listed above are still offered by DWQ, just not on an express timeframe. II. DWQ study on the water quality impacts of small impoundments begins summer 2011 Concerns have been expressed that small, artificial impoundments on stream channels can lead to changes in water quality parameters within the impoundment and in downstream stream reaches. These changes may be significant enough that they may result in a loss of use (e.g. aquatic life use support). Results from a large-scale, probabilistic study of small impoundments by the Tennessee Department of Environment and Conservation (TN DEC 2006) indicated that the impoundments had adverse affects on physical, chemical, and biological components downstream. There are concerns that similar impacts occur in NC as well. During regulatory review of 401 applications, DWQ has had insufficient data on small impoundments within NC to determine whether to include additional conditions in the 401 Certification. Recently, DWQ was awarded a two-year EPA Wetlands Program Development Grant (CD-95471111) which will provide data on small impoundments in North Carolina and to determine if existing data (such as the Tennessee study) are applicable to small impoundments located in the Blue Ridge and Piedmont ecoregions of NC. Grant work began in March 2011, and a Quality Assurance Project Plan (QAPP) was submitted to EPA for review on April 1, 2011. QAPP approval was received from EPA on May 13, 2011. On-site water quality parameters and samples for chemical analyses will be collected from each project site (six sites in the Piedmont and six in the Blue Ridge regions) during three sampling events between May and October 2011. Samples will also be collected for macrobenthos analysis, and an evaluation of periphyton growth will be conducted. Field work and data collection commenced in May 2011.
