SUBJECT: 2022 Division of Mitigation Services Annual Legislative Report

Pursuant to §143-214.13, the Department of Environmental Quality shall report each year by November 1 regarding its progress in implementing the Division of Mitigation Services and its use of the funds in the Ecosystem Restoration Fund. The report shall document statewide wetlands losses and gains, compensatory mitigation performed under G.S. 143-214.8 through G.S. 143-214.12, and gains in acre-feet of flood storage capacity from projects funded under G.S. 143-214.11A. The report shall also provide an accounting of receipts and disbursements of the Ecosystem Restoration Fund, an analysis of the per-acre cost of wetlands restoration, and a cost comparison on a per-acre basis between the State's Division of Mitigation Services and private mitigation banks. The Department shall maintain an inventory of all property that is held, managed, maintained, enhanced, restored, or used to create wetlands or to enhance or restore flood storage capacity under the Division of Mitigation Services. The inventory shall also list all conservation easements held by the Department. The inventory shall be included in the annual report.

The attached report satisfies this reporting requirement.

NC Division of Mitigation

The North Carolina Division of Mitigation Services (DMS) is a nationally recognized Department of Environmental Quality initiative that restores and protects wetlands and waterways for future generations while offsetting unavoidable environmental impacts from development. DMS supports environmentally responsible economic development through the procurement of high-quality restoration projects that satisfy mitigation requirements. From the mountains to the coast, DMS has implemented over 850 projects since inception that have protected more than four-million feet of stream and 80,000 acres of natural areas.

Protecting North Carolina's natural resources is critical to maintaining the state's quality of life, its economic growth and the health and well-being of its residents. DMS works to ensure that cost-effective mitigation alternatives succeed in order to benefit the state's water resources.

DMS offers four In-Lieu Fee mitigation programs designed to assist private and public entities in meeting state and federal compensatory mitigation and nutrient offset requirements. DMS maximizes mitigation investments to restore streams, wetlands and riparian buffer areas using a watershed approach by working with state and local partners, willing landowners, and private vendors. The N.C. Department of Transportation and other developers voluntarily use DMS to move projects forward in a timely and cost-effective manner.

In the Fiscal Year (FY) 2021-22, the DMS:

- Assisted the North Carolina Department of Transportation (NCDOT) to obtain permits for 68 transportation projects by providing 26,741 stream mitigation credits and 109,850 wetland mitigation credits.
- Assisted customers with 245 development projects in the Statewide Stream and Wetland, Riparian Buffer, and Nutrient Offset In-Lieu Fee (ILF) Programs by providing:
 - 97,639.5 stream credits,
 - 50,849 wetland credits,
 - 2,378,160 credits of buffer mitigation (equivalent to 54.6 ac buffer restoration)
 - 90,790 pounds of nitrogen reduction, and
 - 1,441 pounds of phosphorus reduction.
- The 2021-22 Fiscal year represented a large increase from recent years in the number of development projects and amounts of mitigation serviced. DMS assisted multiple mega site development initiatives that had large mitigation needs, such as the Toyota Lithium battery plant.
- DMS received the initial funding for its newest program, the Natural Infrastructure Flood Mitigation Program. Specifically, the NC General Assembly appropriated \$20 million to develop a Statewide Flood Mitigation Blueprint and \$3.5 million for a pilot project in the Stoney Creek watershed.



Natural Infrastructure Flood Mitigation Program

IN 2020, the NC General Assembly created the Natural Infrastructure Flood Mitigation Program (NIFMP) in DNS as part of SL-2079. The session law incorporated flood storage capacity enhancement projects into the activities of and purposes of DMS. However, funding for flood storage projects and flood storage capacity planning was not included in the original law.

In the 2021 Appropriations Act, the North Carolina Department of Environmental Quality, Division of Mitigation Services (DMS) received \$3.5 million in appropriations to create one or more pilot projects addressing chronic flooding in the Stoney Creek watershed impacting businesses, roadways, and access to emergency services in Wayne County and Goldsboro.

The pilot projects shall also serve as the basis for expanding natural infrastructure flood mitigation projects to additional watersheds and scaling solutions to enhance community resiliency across North Carolina.

DMS expect to be under contract in 2022-2023 for the Stoney Creek Pilot Project.

NC Flood Resiliency Blueprint

The 2021 Appropriations Act provided \$20 million for the Division of Mitigation Services to develop North Carolina’s first Flood Resiliency Blueprint. The Blueprint is a statewide watershed planning effort to establish a framework and tools to assist local communities in decision-making related to reducing flood risk and increasing resilience. The Blueprint’s goals are to:

- Identify sources and types of flooding
- Account for existing resilience efforts, programs and funding sources
- Inventory data & identify data gaps
- Develop visualization and decision-making tools that quantify and map flood risk, match appropriate resilience tools and tactics to areas of risk, match available funding sources to specific actions, and prioritize specific actions
- Make recommendations for statewide implementation, including governance and decision-making structures, future Blueprint iteration management, watershed-scale stakeholder engagement, and stewardship of projects that receive state funding.

The Blueprint is expected to be under contract in 2021 and the Draft Blueprint will be completed by December 2023.

Statewide Stream and Wetland Mitigation Losses and Gains

G.S. §143-214.13 requires DMS to document statewide wetland losses and gains and compensatory mitigation performed under G.S. §143-214.8 through G.S. §143-214.12. The data in **Table 1** below have been provided by the Division of Water Resources (DWR*) and reflect



permitting by the Department of Environmental Quality (DEQ). The remainder of this report documents DMS compensatory mitigation.

*Due to permit processes, mitigation and impacts may not (usually do not) occur in the same quarter. Data may include impacts to resources that do not require mitigation (under required thresholds, for example). Due to versions and revisions, different versions of the same project may occur in the same reporting period causing a double calculation of impacts. As of May 4, 2017, the stream mitigation threshold requirements changed. Only impacts 300 linear feet or greater of perennial stream require mitigation. As of June 15, 2020, the wetland mitigation threshold requirements changed. Impacts 0.10 acre or greater of wetlands require mitigation. Mitigation required by USACE applicable to permitted impacts is not tracked by DWR. Data is from the DWR database only.

Property Inventory

During the 2021-2022 fiscal year, the State Property Office closed 18 conservation easement transactions totaling 339 acres associated with DMS’s projects. A complete listing of the properties closed this fiscal year is shown in **Appendix A-1**.

Since program inception, more than 80,000 acres of conservation land or conservation easements have been acquired by DMS and its partners. A complete inventory of all properties associated with DMS projects acquired to date is presented in **Appendix A-2**.

Accounting of Receipts and Disbursements of the Ecosystem Restoration Fund

The Ecosystem Restoration Fund is the account for the Statewide Stream and Wetland In-Lieu Fee (ILF) Program. The Statewide Stream and Wetland ILF Program has two main accounts



Fund 2981 and 2937. **Table 2** below shows the programs financials for the 2021-2022 fiscal year.

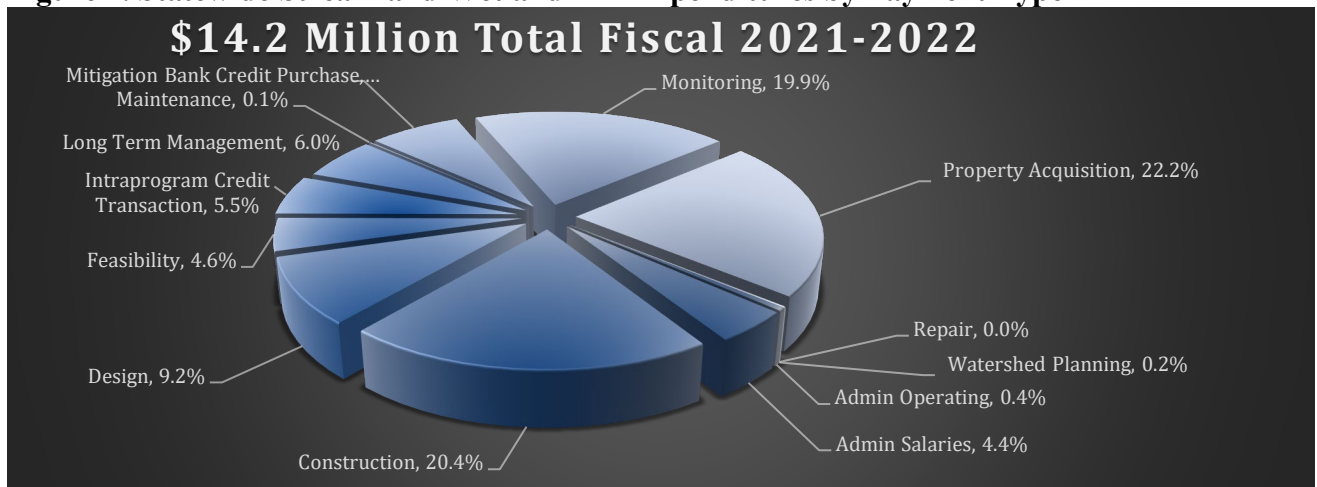

In fiscal 2021-22, DMS accepted 143 new customer ILF payments into the Statewide Stream and Wetland Program, totaling \$62,632,487.45, a 355% increase from the prior year. These 143 customer payments represent 113 development projects, 20,592.925 stream credits and 34.943 wetland credits. **Appendix B** provides Statewide Stream and Wetland Program fiscal 2021-22 receipts and requirements.

Due to the large number of payments collected, the Statewide Stream and Wetland Program will be developing a larger than typical number of mitigation projects over the next year to generate these credits. Stream and Wetland compensatory mitigation projects and contracts typically last 7 to 10 years.

Figure 1 below summarizes the Ecosystem Restoration Fund expenditures by payment type. for the Statewide Stream and Wetland Program. A detailed breakdown of the expenditures is in **Appendix C**.

Mitigation Bank Credit Costs

Reporting requirements of G.S. §143 214.13 require DMS to compare project costs with private mitigation bank rates. For this analysis, DMS used the actual submitted prices for Mitigation Bank Credits from Requests for Bids in the last fiscal year. **Table 3** shows the range in prices for mitigation bank credits in 2021-2022 fiscal year. A complete list of purchased bank credits during 2021-22 are listed in **Appendix D**.

DMS Mitigation Costs

Recent Division of Mitigation Services (DMS) credit costs were summarized by analyzing Full Delivery contracts and Mitigation Bank purchases that DMS awarded over the last 3 fiscal years. **Table 4** includes project contracts, admin, overhead, and other costs required to complete these projects. The program rates for the last 3 years are also summarized. Note that DMS did not contract for any coastal marsh wetland projects in the last 3 years.
