Project Description:

Brack Wilson Pump Station

Replacement and relocation and of existing 450 gpm pump station to include: new 450 gpm pump station (raised 2-feet above the 100-year flood elevation), yard piping, electrical, valves, vaults, and associated appurtenances.

Campground Pump Station

Rehabilitation to include sealing of wet well, and removal and replacement of pavement, roadways, driveways and curbs, and sedimentation and erosion control devices.

Collection system

CCTV and cleaning of approximately 48,000 LF of 6-inch through 12-inch gravity sewer; rehabilitation of 42,769 LF of 6-inch through 12-inch gravity sewer, 875 sewer services, and 218 manholes; replacement of 4,752 LF of 6-inch through 12-inch gravity sewer, 24 manholes, and 97 sewer services.

A map of the project is attached.

The above-named applicant will receive funding assistance from the State Revolving Fund. The North Carolina Division of Water Infrastructure (Division) has conducted a review of the project in accordance with the NCGS §159G-38. The Division has determined that this project is below the minor construction activities threshold outlined in the 15A NCAC 01C .0408; therefore, the project is exempt from inter-agency review, and the preparation of additional environmental documents is not required.

This determination shall become effective upon its distribution by the Division and will be available on the Division's website (<https://deq.nc.gov/about/divisions/water-infrastructure/division-water-infrastructure/environmental-documents>). This determination can be revoked at any time adverse information is made available. The documentation to support this decision will be on file with the North Carolina Department of Environmental Quality, Division of Water Infrastructure, and is available for public scrutiny upon request.
