Question # 45 and Question # 65: Discontinuance of Recycling: We discontinued our curbside recycling program due to significant cost increase as a result of decreased demand for the materials. In lieu of collection, we now offer a drop site that is collected as needed for a flat rate per pull (note from Dana Hill). During 2017 This change occurred in April 2018. During 2017 the town got a new vendor called Pak R to manage a drop off program. They had decided to go away from the curbside with Carolina Waste Management. The staff informed me they had no commingled recycled tons for drop off. The vendor PAK R failed to provide them adequate information to determine if the reported information from them was legitimate. We discussed this on the phone on 8-6-2018 for several minutes to see if we had tons to report. He could not find anything in his files. In April 2018, the Town board decided to rade issues that made it more economical for the change. (8-6-2018 phone conversation with Mr. Dana Hill). Note also in the FY 2016-17 ASWR report that the town also reported lower volume from recycling with no explanation when Carolina Waste Management was doing this work.

Question # 51: This facility at 207 Carolina Drive is permitted as a disaster debris site. It has not at this time applied for a Yard Waste Notification Site status and is not an LCID facility. Spoke to Dana Hill and he said that the town will apply for it this year (8-6-2018)
