July 13-14, 2022 Meeting
Agenda Item E – 2022 Update on and Designation of Systems as Distressed**

Division of Water Infrastructure Staff Report

Background

Session Law 2020-79, entitled in part “An Act to Improve the Viability of the Water and Wastewater Systems of Certain Units of Local Government...”, authorizes the State Water Infrastructure Authority (Authority) and Local Government Commission (Commission or LGC) to develop criteria to assess and review local government units (LGUs), and to utilize the assessment and review process to identify distressed units.

In the Fall of 2020, the Authority and Commission developed the Identification Criteria and Assessment Criteria to evaluate local government units and identify distressed units. The Authority adopted the Assessment Criteria and the Identification Criteria at its meeting on November 18, 2020.

Identification Criteria

The Authority and Commission adopted the following Identification Criteria to be used to identify distressed units:

1. An LGU whose fiscal affairs are under the control of the LGC pursuant to its authority granted by G.S. 159-181 (“under LGC fiscal control”), or
2. An LGU that has not submitted its annual audits for the last two (2) fiscal years to the LGC as required by G.S. 159-34, or
3. An LGU with a total Assessment Criteria score that:
 - a) Equals or exceeds 9 for LGUs providing both drinking water and wastewater services, or
 - b) Equals or exceeds 8 for LGUs providing only one service, either drinking water or wastewater, or
4. An LGU for which other information is available to or known by the Authority or Commission that reflects and is consistent with, but does not expressly appear in, the Assessment Criteria to account for situations in which the Assessment Criteria score does not wholly or accurately reflect a system’s level of risk due to the limitations of available data.

Initial Assessment and Distressed Designations

In late 2020 and early 2021, Division and Commission staff compiled LGU data in accordance with the approved criteria to identify distressed LGUs. Initially, 119 LGUs were identified as

potentially distressed based on the approved criteria. Based on additional review and information received from LGUs, some of the 119 were determined to not be distressed or to no longer have active systems, 18 LGUs had their potential designations as distressed put on hold for further review, and the remainder were officially designated as distressed by the Authority and Commission.

Based on this initial assessment, 93 LGUs with active water and/or wastewater systems were designated as distressed, excluding three LGUs that were previously designated and no longer had active water or sewer utilities. Once designated, LGUs must meet the requirements of the Viable Utility program before the designation is removed, even if future assessment scores drop below the threshold for designation.

Reassessment Update

At the Authority’s April 13-14, 2022 meeting, staff presented and the Authority approved a slate of new distressed designations based on the Spring 2022 reassessment. This included eleven (11) LGUs that had not submitted their annual audits for the past two fiscal years (which are automatically designated upon Commission approval) as well as twelve (12) LGUs that were put “on-hold” at their request after the initial assessment, and which scored above the threshold upon reassessment in 2022. The Commission approved the same slate of distressed designations during their April 26, 2022 special meeting.

Subsequent to approval of the designations based on the 2022 reassessment, Division and Commission staff discovered an error in the reassessment calculations whereby outdated financial data had been used for some scoring criteria, resulting in inaccuracies in the designations approved in April. Accordingly, Division staff reran the reassessment calculations using the correct dataset, including audited 2021 financial data that had been received by the Commission prior to the deadline for submission to be included in the annual reassessment (March 1, 2022). The results of the recalculated reassessment are provided in Attachments E-1 and E-2 which replace Attachments J-2 and J-3 from the April Authority meeting.

Upon recalculation of the reassessment scores, staff determined that three (3) of the twelve (12) units which were designated in May scored below the designation threshold using the corrected data: Beaufort County, Edgecombe County, and Granite Falls.

Upon review of their letters requesting that their designation be put on hold after the initial assessment in 2021, and their current assessment scores, staff confirmed that Beaufort County and Granite Falls should not be considered distressed units. However, Edgecombe County’s

score – which was above the threshold in 2021, but below the threshold based on the 2022 reassessment recalculation – was influenced by several missing assessment data inputs because their FY21 audit data had not been received by the Commission in time for the original Spring 2022 reassessment. If this data had been used in the reassessment, Edgecombe County would have scored well above the designation threshold with a score of 12 (reference Attachment E-4). Upon further review, staff also noted that Edgecombe County had several other characteristics that warrant consideration for distressed designation; specifically:

- The County has been actively leading and facilitating regionalization efforts throughout the county including efforts to address water and wastewater issues in the Town of Princeville, the Town of Speed, and unincorporated areas in the County. These efforts align with the intent of Session Law 2020-79 to improve the viability of water and wastewater systems of local governments.
- In April and May, the Authority and Commission respectively approved the award of a \$1,982,800 VUR grant to Edgecombe County to replace an existing loan for a project to replace and expand a booster pump station based on the County’s designation as distressed by the Authority and Commission.
- The County suffered a significant loss to their community and county tax base following the tragic fire at the QVC distribution facility in December 2021, the impacts of which are not yet reflected in their financial information.
- The County has expressed interest in being designated as distressed under the Viable Utilities program (see attached Letter of Support from Edgecombe County, Attachment E-3).

Recalculation of the reassessment scores also resulted in changes to the list of LGUs exceeding the designation threshold for the first time, expanding the list from 23 units to 32 units, per Table 1 below. As previously discussed with the Authority, notifications to first-year LGUs are handled by staff without any official action required by the Authority or Commission. Note that first-year exceedance letters were sent after the 2022 assessment scores were corrected, so only the 32 units correctly identified as scoring above the threshold received notification letters. The scoring status of first-year LGUs are summarized below (green font means the unit was added to the list, red font means the unit was removed from the list based on the corrected scores and was never formally notified as being above the designation threshold).

Requests for Designation by “First-Year” LGUs

LGUs exceeding the designation threshold for the first year have the option of requesting designation by the Authority and Commission instead of waiting for a second year of assessment. Division staff have sent notification letters to the 32 first-year LGUs in the table above, and requested notification of the unit’s interest in becoming designated before July 1, 2022. Staff is requiring that units interested in designation provide a Board resolution requesting designation before bringing potential actions to the Authority and Commission so that LGUs and their boards understand the commitment they are making if they become designated. As of this staff report, a total of six (6) units have formally requested designation and provided appropriate resolutions. An additional eleven (11) units have indicated that they are interested in designation but did not have time to pass a resolution prior to the July Commission and Authority meetings. Staff will continue to collect resolutions and will bring those respective LGUs forth for consideration for designation by the Authority and Commission in September.

Division and Commission staff, with the assistance of the Southeast Rural Communities Development Project (SERCAP), have been working with the Town of Love Valley on its long-standing challenges providing reliable and compliant community wastewater service to its residents. Through the process of providing this support, staff discovered that Love Valley had never been assessed, despite owning and managing a small wastewater system. Accordingly, Love Valley has been added to the master list of assessed units and scored above the designation threshold in their first assessment following the Spring 2022 reassessment protocol with a score of 11 (for a single utility service – wastewater). Love Valley has indicated that they will submit a resolution in support of designation prior to the July Authority meeting and has both acute and long-term needs for VU program support.

Staff Recommendations

Staff recommend that the Authority take the following actions:

1. Rescind the distressed designations for Beaufort County and Granite Falls, and retain designation for Edgecombe County, per the table below which summarizes the changes for all the LGUs that were placed on-hold following the initial assessment in 2021.

Edgecombe County was originally identified in April for designation as a distressed unit, but when the scores were recalculated to address the data error, Edgecombe County's recalculated score is 7, below the threshold for designation. The County had not submitted their audit data before the deadline of March 1, 2022, so the missing data makes their score artificially low. Now that the audit data is in, the score has been recalculated at 12 points, which is above the threshold for designation.
