Fall 2023 Application Round, Example Funding Scenario, and Funding Decisions for Local Assistance for Stormwater Infrastructure Investments (LASII) Stormwater Planning Projects

# **Division of Water Infrastructure Staff Report**

This report presents a *preliminary* funding scenario for the consideration of the State Water Infrastructure Authority (Authority). Subsequent updates and corrections to the application information and funding scenario (including application scores, ranking, potential funding amount, etc.) may occur and will be presented to the Authority during the meeting on February 20<sup>th</sup>. Applications are selected for funding by the Authority during the meeting, and the Authority's selections are final.

# **Background**

This staff report presents background information on the Fall 2023 Application Round for stormwater planning applications to be funded from the Local Assistance for Stormwater Infrastructure Investments (LASII) fund. The Fall 2023 application round includes funds appropriated to Water Infrastructure Funds established in G.S. 159G. This information includes a summary of available funds and any limitations on awarding the funds, a summary of applications received, and the process staff used to apply funds in the funding scenario example presented to the Authority. Funding demand exceeded available funds.

#### **Fall 2023 Funds Available**

The December 12, 2023, Authority meeting included a staff presentation of Session Law 2023-134; that Session Law provided the currently available LASII funds. Session Law 2023-134 requires that eligible entities for these funds are as defined in Section 12.14 of Session Law 2021-180 for projects that will improve or create infrastructure for controlling stormwater quantity and quality.

Of the approximately \$15 million available for award, staff recommended that approximately 20 percent of the funds be allocated to LASII planning projects and approximately 80 percent be allocated to LASII construction projects, which mirrors the approximate percentage split of funding requested in the applications received for Fall 2022. During the December 2023 meeting, staff also recommended that only stormwater planning projects in the amount of approximately \$3 million be awarded for the Fall 2023 stormwater planning applications and that the remaining approximately \$12 million be awarded only for stormwater construction projects for applications received in the Fall 2023 and Spring 2024 funding rounds. Stormwater construction applications from Fall 2023 and Spring 2024 would be reviewed together after the Spring 2024 application deadline. If the Authority chooses to award more than approximately \$3 million for planning projects this round, then there will be less funding available for construction projects to be considered in Spring 2024.

# Summary of LASII Stormwater Planning Applications Received and Considered

A total of 18 stormwater planning grant applications were submitted for the Fall 2023 application round. Of these, eight were not eligible for consideration for funding because the applications did not contain all the information required. An additional eight unfunded Spring 2023 stormwater planning grant applications were reconsidered as part of this application round. The reconsidered applications were rescored according to the Fall 2023 Priority Rating System. A total of 26 stormwater planning grant applications were considered for Fall 2023 funding. The LASII stormwater applications considered are summarized in Tables 1 and 2.

Applications received for were evaluated to determine if the applicants were eligible entities and then scored in accordance with the Authority-approved Priority Rating System (PRS) for stormwater planning.

#### **Example Funding Scenario for LASII Stormwater Planning Grants**

The Authority may consider multiple funding scenarios. In the example funding scenario presented, applications are shown as receiving funds as follows:

• LASII stormwater planning grant limits of \$400,000 or \$500,000 per applicant per round were applied. These limits were set when LASII was first established through NC DEQ's Plan to

Administer American Rescue Plan Act's State Fiscal Recovery Fund Appropriated in the State Budget for Stormwater Projects, and these limits have continued for consistency within the LASII program.

• Funding is proposed in priority order until LASII funds available for this round are exhausted.

In the example funding scenario presented, eight stormwater planning grant applications would receive \$2,945,000 in LASII grants. Table 3 summarizes the example funding scenario.
