

Applications selected for funding by the State Water Infrastructure Authority on July 16, 2024

On July 16, 2024, North Carolina's State Water Infrastructure Authority (SWIA) approved funding assistance (loans and/or grants) for the following applications. Applicants will be notified of their funding awards by the NC Department of Environmental Quality's Division of Water Infrastructure with a Letter of Intent to Fund.

Construction project types include Drinking Water, Bipartisan Infrastructure Law (BIL) Drinking Water Emerging Contaminants, Wastewater (including stormwater funded from the CWSRF), Drinking Water (Community Development Block Grant -- Infrastructure [CDBG-I]), Wastewater (CDBG-I), DWSRF Lead Service Line Replacement Projects, and Stormwater Construction Projects. Planning project types include Asset Inventory and Assessment grants (Viable Utility Reserve) and BIL DWSRF-LSLR inventories.
