

North Carolina State Implementation Plan Revision: Inspection and Maintenance (I&M) Program

Clean Air Act Section 110(1) Noninterference Demonstration to Remove 26 Counties from North Carolina's Motor Vehicle Emissions Inspection and Maintenance (I&M) Program

Introduction

On October 5, 2017, a pre-hearing version of the "North Carolina State Implementation Plan Revision: Inspection and Maintenance (I&M) Program" and "Clean Air Act Section 110(I) Noninterference Demonstration to Remove 26 Counties from North Carolina's Motor Vehicle Emissions Inspection and Maintenance (I&M) Program" was released for public comment. A request for public hearing, in accordance with 40 CFR 51.102, and the public comment period were published on the North Carolina Division of Air Quality (DAQ) website, as well as to email distribution lists managed by the DAQ. The public comment period was open from October 5, 2017 through November 6, 2017. No requests for a public hearing were received. The public comment period elicited comments from the United States Environmental Protection Agency (EPA) and three members of the public.

Background

The North Carolina General Assembly enacted Session Law 2017-10, Senate Bill 131 (An Act to Provide Further Regulatory Relief to the Citizens of North Carolina) which revised the state's I&M program. Section 3.5.(a) of the Act amended North Carolina General Statute §143-215.107A(c) to remove 26 of 48 counties from North Carolina's I&M program. The I&M program change will increase emissions of nitrogen oxides (NOx), volatile organic compounds (VOC), and carbon monoxide (CO) in counties where the vehicle emissions inspection requirements would be removed. Thus, a State Implementation Plan (SIP) revision is being submitted to EPA to demonstrate that air quality would be maintained and that the SIP complies with the requirements of Section 110(1) of the Clean Air Act (CAA), as amended.

Based on a technical study of county-level emissions increases associated with the proposed I&M program change, and current ambient air quality data, the DAQ concludes that removing the 26 counties from North Carolina's I&M SIP will not interfere with continued attainment or maintenance of any applicable National Ambient Air Quality Standards (NAAQS). Therefore, the DAQ is requesting EPA's approval to remove 26 counties from North Carolina's I&M SIP, which is a required before North Carolina can officially remove the counties from the I&M program.

In addition, the DAQ is proposing revisions to the SIP to update program-related data and to remove Section C (Basic I&M Performance Standards) of the SIP. The DAQ is proposing to

remove Section C from the SIP because (1) performance standard modeling is no longer required since the I&M program areas for which it was previously required have been redesignated to attainment for the pollutants that originally triggered this I&M requirement, and (2) the I&M program is being continued as part of the area's maintenance plan.

With this submission, the DAQ believes it has in good faith addressed the requirements of CAA Section 110(l) relative to removing 26 counties from North Carolina's I&M program and requests that EPA approve the proposed revisions to the North Carolina I&M SIP.

Summary of Public Comment Period

The public notice comment period was open from October 5, 2017 through November 6, 2017. There were no requests for a public hearing. Comments were received from EPA and three members of the public, which are attached following this report.

The following is a summary of the pertinent comments raised during the public comment period, along with the DAQ's response.

EPA comment: EPA completed its review of the submittal and offered no comments at this time.

DAQ response: The DAQ acknowledges this comment. No revisions are required.

Comments Submitted by Members of the Public:

Mr. John Allen, Mr. Phil Hammett, and Mr. Bryan Leonard each submitted comments supporting removal of the 26 counties from the I&M program.

DAQ response: The DAQ acknowledges these three comments. No revisions are required.

The North Carolina Department of Environmental Quality, Division of Air Quality (DAQ), hereby gives notice regarding its Pre-hearing Draft of the State Implementation Plan (SIP) Revision and Clean Air Act (CAA) Section 110(1) Noninterference Demonstration for Removing 26 Counties from North Carolina's Emissions Inspection and Maintenance (I&M) Program. Section 3.5.(a) of Session Law 2017-10 amended North Carolina General Statute (NCGS) §143-215.107A(c) to remove 26 of 48 counties from North Carolina's I&M program. Based on a technical study of county-level emissions increases associated with the proposed I&M program change, and current ambient air quality data, the DAQ concludes that removing the 26 counties from the I&M SIP will not interfere with continued attainment or maintenance of any applicable NAAQS. With these submittals, the DAQ is requesting EPA's approval to remove 26 counties from North Carolina's I&M SIP, which is a required before North Carolina can officially remove the counties from the I&M program. Persons wishing to submit comments or request a public hearing are invited to do so.

COMMENT PROCEDURES:

Any person wishing to comment may submit a written statement for inclusion in the record of proceedings regarding the Pre-hearing Draft of the SIP Revision and CAA Section 110(l) Noninterference Demonstration for Removing 26 Counties from North Carolina's I&M Program. Written comments should be received by no later than November 6, 2017.

REQUESTS FOR A PUBLIC HEARING:

Requests for a public hearing must be in writing and include a statement supporting the need for such a hearing, an indication of your interest in the subject, and a brief summary of the information intended to be offered at such hearing. A public hearing will be scheduled if requested. A separate notice will be announced for the hearing including the date, time and location. Written requests for a public hearing should be received no later than October 19, 2017, and addressed to Randy Strait, Division of Air Quality, 1641 Mail Service Center, Raleigh, North Carolina 27699-1641.
