1. Request for a Major Variance from the Randleman Lake Riparian Area Protection Rule by Sedgefield Country Club Acquisition, LLC for a New Short Game Practice Facility at Sedgefield Country Club at 3201 Forsyth Drive, Greensboro NC - (Action Item) (Sue Homewood, 401 and Buffer Permitting Branch, Division of Water Resources)

A request has been received for the Water Quality Committee to grant a Major Variance from the Randleman Lake Riparian Area Protection Rule (15A NCAC 02B .0250) to Sedgefield Country Club Acquisition LLC for the construction of the proposed new Short Game Practice facility within Zone 1 and Zone 2 of the buffer at 3201 Forsyth Drive in Greensboro, Guilford County, NC. Guilford County has been designated authority to administer the Randleman Lake Riparian Area, Protection Rule. The applicant proposes to implement a stringent fertilizer management program and to install and maintain two Filterra biofiltration stormwater control systems to protect water quality. To mitigate the buffer impacts, the applicant proposes to purchase buffer credits from the NC Division of Mitigation Services In-Lieu Fee program and the Wildlands Holdings Randleman Lake Umbrella Mitigation Bank Instrument: Loflin Dairy Phase II Site. Based on the information submitted, the Guilford County Board of Commissioners

approved this request for a Major Variance from the Randleman Lake Riparian Area Protection Rule on March 19, 2020.
