Example Funding Scenario for Drinking Water Projects for Spring 2018 Application Round

Division of Water Infrastructure Staff Report

This staff report presents an example funding scenario for drinking water project applications. A total of 24 applications were received requesting \$115 million in funding. In this example, applications are shown as funded in priority order until available funds are exhausted. Grant funds are provided at the percentage determined by the affordability criteria established by the Authority. The funding scenario provided utilizes all remaining Connect NC bond grant funds. Approximately \$700,000 in Connect NC bond loan funds will remain unused and made available for cost overruns for previously funded projects.

A total of 19 drinking water projects totaling \$36,191,118 are proposed to be funded as shown in Tables I-1 and I-2 below.

Example Funding Scenario for Wastewater Projects for Spring 2018 Application Round

Division of Water Infrastructure Staff Report

This staff report presents an example funding scenario for wastewater project applications. A total of 24 applications were received requesting \$123 million in funding. In this example, applications are shown as funded in priority order until available funds are exhausted. There are no remaining State Grant Funds available. The best available funds are State Revolving Fund with principle forgiveness. The funding scenario provided utilizes all remaining Connect NC bond funds.

There are three projects on the Clean Water State Revolving Fund list that receive a total of 14 priority points. The Town of Southport Project No. 16 is additional funding for a previously funded project. The Lincoln County Project No. 17 cannot be fully funded but will move forward with partial funding. A total of 15 wastewater projects totaling \$64,234,624 are proposed to be funded as shown in the example detailed in Tables J-1 and J-2 below.
