Separate sealed bids for the City of High Shoals, NC for the High Shoals Sewer CDBG-I Project will be received at the High Shoals City Hall, 101 Thompkins Street, High Shoals, NC 28077 on Friday, February 15, 2019 at 11:00 am, then at said office to be publicly opened and read aloud. The bidder shall show such evidence by clearly displaying his or her current license number on the outside of the sealed envelope in which the proposal is delivered.

The Project consists of constructing approximately 6,443 LF of 8 inch sanitary sewer, 37 manholes, the installation of 80 sewer taps and 3,950 LF service laterals, and associated items of construction as more clearly defined in the Contract Documents.

Bidding Documents may be obtained from the Issuing Office during the hours indicated above. Bidding Documents are available on compact disc (as portable document format (PDF) files) for a non-refundable charge of \$30.00, including shipping via overnight express service. Alternatively, printed Bidding Documents may be obtained from the Issuing Office either via in-person pick-up or via mail, upon Issuing Office's receipt of payment for the Bidding Documents. The non-refundable cost of printed Bidding Documents is \$50.00 per set, payable to Robinson & Sawyer, Inc. plus a non-refundable shipping charge. Upon Issuing Office's receipt of payment, printed Bidding Documents will be sent via the prospective Bidder's delivery method of choice; the shipping charge will depend on the shipping method chosen. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the prospective Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.

Bids will be received for a single prime Contract. Bids shall be on a lump sum and unit price basis as indicated in the Bid Form.

A Pre-Bid Conference will be held at the High Shoals City Hall, 101 Thompkins Street, High Shoals, NC on Tuesday, January 29, 2019 at 2:00 pm. Attendance at the pre-bid conference is highly encouraged but is not mandatory.
