Separate sealed bids for the Town of Troy Water and Sewer Replacement Project will be received at the Troy Town Hall, 315 North Main Street, Troy, North Carolina, on **March 5, 2019 at 2:00 p.m.**, then be publicly opened and read aloud. The bidder shall show evidence of appropriate contractor's license by clearly displaying his or her current license number on the outside of the sealed envelope in which the bid is delivered.

The project includes construction of approximately 1,500 LF of 6-inch PVC and DIP water lines and related appurtenances and construction of approximately 1,700 LF of 8-inch PVC and DIP gravity sewer lines and related appurtenances.
